AN ORDINANCE OF THE CITY OF PORT ST. LUCIE, FLORIDA, AMENDING THE COMPREHENSIVE PLAN OF THE CITY OF PORT ST. LUCIE TO INCLUDE A SMALL-SCALE AMENDMENT TO THE FUTURE LAND USE MAP FOR THE ST. ANDREWS PARK COMMERCIAL, LLC. PROPERTY (P21-142) TO CHANGE THE FUTURE LAND USE DESIGNATION OF APPROXIMATELY 4.37-ACRES FROM CG (GENERAL COMMERCIAL) TO ROI (RESIDENTIAL, OFFICE, INSTITUTIONAL) FOR A PARCEL LEGALLY DESCRIBED AS PARCELS B AND C ST. ANDREWS PARK COMMERCIAL, AND GENERALLY LOCATED ON THE NORTH SIDE OF NW ST. JAMES BOULEVARD AND WEST OF ST. JAMES DRIVE; PROVIDING FOR CONFLICT; PROVIDING FOR SEVERABILITY; AND PROVIDING AN EFFECTIVE DATE.

WHEREAS, the City of Port St. Lucie, Florida ("City"), has adopted a comprehensive plan known as the City of Port St. Lucie Comprehensive Plan adopted by Ordinance 97-50 and subsequently amended via Ordinance 12-19; and

WHEREAS, the City is committed to planning and managing the growth of the City; and WHEREAS, the City has the authority to amend its Comprehensive Plan pursuant to Chapter 163, Part II, Florida Statutes; and

WHEREAS, the City Council of the City of Port St. Lucie desires to amend the Future Land Use Map portion of the Comprehensive Plan to guide and control the future development of the City and to preserve, promote and protect the public's health, safety and welfare; and

WHEREAS, Andrew's Park Commercial, LLC has submitted a small-scale amendment (P21-142), to amend the Future Land Use Map of the City of Port St. Lucie Comprehensive Plan in accordance with Section 163.3187, Florida Statutes to change approximately 4.37-acres from the future land use designation of CG (General Commercial) to ROI (Residential, Office, Institutional) for property legally described as Parcels B and C of St. Andrews Park Commercial, a replat according to the plat thereof recorded in Plat Book 59, Pages 9 through 13 of the public records of St. Lucie County, and located on the north side of NW St. James Boulevard and west of NW St. James Drive; and

WHEREAS, the City of Port St. Lucie Planning and Zoning Board has been duly designated as the local planning agency pursuant to Section 163.3174 et. seq., Florida Statutes; and

WHEREAS, the Planning and Zoning Board met on August 3, 2021, at a duly noticed public meeting, and pursuant to the procedures of Chapter 163, Florida Statutes, Part II, reviewed and heard

testimony concerning the proposed amendment (P21-142) to the City's Comprehensive Plan, and submitted its recommendations thereon to the City Council; and

WHEREAS, the City Council held a public hearing on August 23, 2021 to consider the proposed small-scale amendment, advertising of the public hearing having been made; and

WHEREAS, the City Council has considered the testimony and evidence, as well as the recommendation of staff and the Planning and Zoning Board, and the City Council has determined that the proposed amendment is consistent with the intent and direction of the City's Comprehensive Plan and wishes to amend the Comprehensive Plan Future Land Use Map as provided herein; and

WHEREAS, all the necessary hearings and public notices, in conformity with procedural and substantive requirements of Florida Statutes and the Comprehensive Plan have been complied with.

NOW, THEREFORE, THE CITY OF PORT ST. LUCIE HEREBY ORDAINS:

<u>Section 1</u>. <u>Ratification of Recitals</u>. The City Council of the City of Port St. Lucie, Florida, hereby adopts and ratifies those matters as set forth in the foregoing recitals.

Section 2. <u>Authorized Amendment to the Comprehensive Plan</u>. The Comprehensive Plan of the City of Port St. Lucie is hereby amended in the following respect:

The Future Land Use Map is hereby amended to designate approximately 4.37-acres of land legally described as Parcels B and C of St. Andrews Park Commercial, a replat according to the plat thereof recorded in Plat Book 59, Pages 9 through 13 of the public records of St. Lucie County, Florida, from the future land use designation of CG (General Commercial) to ROI (Residential, Office, Institutional), which said amendment consists of modifications to the Future Land Use Map as provided in this amendment.

Section 3. Future Land Use Map Adopted. The Future Land Use Map of the City of Port St. Lucie is hereby amended from the future land use designation of CG (General Commercial) to ROI (Residential, Office, Institutional). The official Future Land Use Map of the City of Port St. Lucie Comprehensive Plan shall be conformed as set forth by this Comprehensive Plan Amendment.

<u>Section 4.</u> Conflict. If any ordinances, or parts of ordinances, or if any sections, or parts of sections, of the ordinances of the City of Port St. Lucie, Florida, are in conflict herewith, this Ordinance shall control to the extent of the conflicting provisions.
