#### 1. Additional Scope:

#### a. Task 1: Additional One-on-One Meetings (Hourly)

i. CSG, along with its sub-consultant Kittelson & Associates ("Consultant Team"), will participate in up to six (6) one-on-one meetings with the City Manager and each of the City's elected officials to present the findings of the *Planning and Infrastructure Study* prepared by the Consultant Team. These one-on-one meetings will be conducted via mutually accepted virtual meeting platform (Teams, Webex, Zoom, etc.), are anticipated to be no more than one-hour in length, and are expected to occur between March 26, 2024, and April 30, 2024.

## b. Task 2: Additional Support (Hourly)

i. Beyond the meetings and support described in Task 1 above, if additional meetings, detailed conversations, presentations, or other support be requested or necessary, they will be subject to standard hourly billing rates attached hereto as Exhibit B.

## c. Schedule and Meetings

- i. GAI will endeavor to complete its Scope of Services for this Supplemental Services Proposal on a per task basis as described below:
- ii. Task 1: Additional One-on-one Meetings
- iii. No more than six (6) One-on-one meetings, which will be conducted virtually between March 26, 2024, and April 30, 2024, subject to excused delay occasioned by factors beyond GAI's reasonable control.
- 2. TERMS REVISION. The following modifications to the Terms and Conditions contained in the Contract are hereby incorporated and made part of that Contract.
- 3. SUCCESSORS AND ASSIGNS. This Amendment #3 shall be binding upon and inure to the benefit of the successors and permitted assigns of the parties hereto.
- 4. ENTIRE AGREEMENT. Except as expressly modified by this Amendment #3, the contract shall be and remain in full force and effect in accordance with its terms and shall constitute the legal, valid, binding and enforceable obligations to the parties. This Amendment #3 and the contract (including any written amendments thereto), collectively, are the complete agreement of the parties and supersede any prior agreements or representations, whether oral or written, with respect thereto.
