


Location Map

Background:


The property is vacant and located on the south side of SW Leafy Road between SW Tropical Terrace and SW Villanova Road (its western terminus with SW Leafy Road)

The property has an existing zoning district of Institutional (I) and a future land use designation of Institutional (I). In order to accommodate the proposed single-family dwelling units, the applicant is requesting to amend the future land use designation to Institutional (I) and zoning district to Residential, Low Density (RL).
