

RESOLUTION 25-R__

A RESOLUTION OF THE CITY OF PORT ST. LUCIE, FLORIDA, AUTHORIZING THE MAYOR, OR HER DESIGNEE, TO ENTER INTO AND EXECUTE AN AMENDMENT TO A LOCALLY FUNDED AGREEMENT BETWEEN THE STATE OF FLORIDA DEPARTMENT OF TRANSPORTATION AND THE CITY OF PORT ST. LUCIE FOR DESIGN SERVICES IN CONNECTION WITH PORT ST. LUCIE BOULEVARD RECONSTRUCTION PROJECT FROM SOUTH OF PAAR DRIVE TO SOUTH OF DARWIN BOULEVARD; PROVIDING FOR CONFLICT; PROVIDING FOR SEVERABILITY; AND PROVIDING AN EFFECTIVE DATE.

WHEREAS, on August 28, 2019, the State of Florida Department of Transportation (“FDOT”) and the City of Port St. Lucie (“City”) entered into a Locally Funded Agreement (“Agreement”) to provide financial assistance for the design services in connection with the Port St. Lucie Boulevard roadway reconstruction project from South of Paar Drive to South of Darwin Boulevard, Item/Segment No. 431752-2-32-03, for the project known as PSL Boulevard South Segment 2 (“Project”); and

WHEREAS, on September 19, 2019, FDOT received the City’s financial contribution of \$791,852.00, as required by the Agreement; and

WHEREAS, the project required design revisions adjusting the roadway profile to accommodate thirty-five (35) newly constructed driveways along the project corridor, resulting in additional design and project costs; and

WHEREAS, the estimated total design cost of the Project is Three Million Six Hundred Eighty-six Thousand Six Hundred Forty-five Dollars and no cents (\$3,686,645.00); and

WHEREAS, the City’s share for the design services has increased; therefore, the City is required to pay the additional amount of \$151,339.00; and

WHEREAS, FDOT has requested that the City enter into Amendment Number One to the Agreement (“Amendment”) to provide the required funding; and

WHEREAS, the City Council hereby determines that the parties may enter into the Amendment as it serves a public purpose.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY OF PORT ST. LUCIE, FLORIDA:

Section 1. Recitals. The City Council hereby adopts and ratifies those matters set forth in the foregoing recitals.

Section 2. The Mayor, or her designee, is hereby authorized to enter into and execute the Amendment, in substantially in the form as attached hereto as Exhibit “A”, and such other

documents necessary to implement the terms of said Agreement as amended. The City Manager, or his designee, is further authorized to take all actions necessary to implement the terms and conditions of the Agreement and accomplish the purposes set forth therein.

Section 3. Conflict. If any resolution, or parts of any resolution, are in conflict herewith, this Resolution shall control to the extent of the conflicting provisions.

Section 4. Severability. The provisions of this Resolution are intended to be severable. If any part of this Resolution is determined to be void or is declared illegal, invalid, or unconstitutional by a Court of competent jurisdiction, the remainder of this Resolution shall remain in full force and effect.

Section 5. Effective Date. This Resolution shall become effective immediately upon adoption.
