

RESOLUTION NO. 22-_____

A RESOLUTION APPROVING A PRELIMINARY AND FINAL PLAT FOR SOUTHERN GROVE PLAT NO. 36 1ST REPLAT, WITHIN THE CITY OF PORT ST. LUCIE, FLORIDA ON THE REQUEST OF ANGLO AMERICAN LAND, LLC; PROVIDING FOR CONFLICTS; PROVIDING FOR SEVERABILITY; AND PROVIDING AN EFFECTIVE DATE (P22-207).

WHEREAS, the City of Port St. Lucie, Florida has been requested by Velcon Engineering & Surveying, LLC., acting as agent for the Anglo American Land Company, LLC, owner, to approve a preliminary and final plat for Southern Grove Plat No. 36 1st Replat, within the City of Port St. Lucie, Florida; and

WHEREAS, there are no public/private improvements, i.e., roads, drainage, and utility facilities, to be constructed within the platted area; and

WHEREAS, the plat conforms, to Section 156, Port St. Lucie City Code, and meets all State requirements for such plats; and

WHEREAS, the Site Plan Review Committee, on July 27, 2022, recommended approval of the preliminary and final plat (P22-207).

NOW, THEREFORE, BE IT RESOLVED BY THE CITY OF PORT ST. LUCIE, FLORIDA:

Section 1. Ratification of Recitals. The foregoing recitals are hereby ratified and confirmed as true and correct and are hereby made a part of this Resolution.

Section 2. That the City Council hereby approves the preliminary and final plat for Southern Grove Plat No. 36 1st Replat, within the City of Port St. Lucie, Florida, said plat being offered by Anglo American Land Company, LLC, as owner and title holder of said property and as prepared by Robert F. Kemerson, Velcon Engineering & Surveying, LLC, as designated on the attached Plat.

Section 3. That the Mayor and City Clerk of the City of Port St. Lucie, Florida, are hereby authorized to countersign the attached plat so it may be properly recorded in the public records of St. Lucie County, Florida.

Section 4. If any Resolution, or parts of any Resolution, are in conflict herewith, this Resolution shall control to the extent of the conflicting provisions.

Section 5. The provisions of this Resolution are intended to be severable. If any part of this Resolution is determined to be void or is held to be invalid by a Court of competent jurisdiction, then the remainder of this Resolution shall remain in full force and effect.
