## **RESOLUTION 23-R**

A RESOLUTION OF THE CITY OF PORT ST. LUCIE, FLORIDA, AUTHORIZING THE CITY MANAGER TO ENTER INTO A RIGHT-OF-WAY CONSENT AGREEMENT WITH FLORIDA POWER & LIGHT COMPANY, A FLORIDA CORPORATION, WHICH IS NECESSARY FOR THE CONSTRUCTION AND MAINTENANCE OF THE EXTENSION OF CROSSTOWN PARKWAY AT RANGE LINE ROAD; PROVIDING FOR CONFLICT; PROVIDING FOR SEVERABILITY; AND PROVIDING AN EFFECTIVE DATE.

**WHEREAS,** Florida Power & Light Company, a Florida corporation ("FPL"), is the current holder of that certain right-of-way granted under that certain instrument recorded in Official Record Book 2785, at Page 1767, in the Public Records of St. Lucie County, Florida (the "Easement"); and

WHEREAS, the final segment of the roadway in the extension of Crosstown Parkway at Range Line Road is in the process of being completed within the limits of the City of Port St. Lucie, Florida (the "City"), and the projected right-of-way intersects with the Easement; and

WHEREAS, FPL has consented to the City using those certain portions of the real property located within its Easement under the terms and conditions set forth in the Right-of-Way Consent Agreement (the "Agreement"), attached hereto as Exhibit "A", solely for the purpose of construction and maintenance of the extension of Crosstown Parkway at Range Line Road, to include sidewalks, street lighting, drainage pipes, water main, fiber optic conduits, underground lighting, and no lighting or landscaping over 14' (the "Project"), all in accordance with the approved plans and specifications; and

**WHEREAS,** FPL requires the City to enter into the Agreement in order to construct and maintain those portions of the Project located within the Easement; and

**WHEREAS,** the City Council hereby determines that the parties may enter into the Agreement as it serves a public purpose.

## NOW, THEREFORE, BE IT RESOLVED BY THE CITY OF PORT ST. LUCIE, FLORIDA:

<u>Section 1.</u> <u>Ratification of Recitals</u>. The foregoing recitals are hereby ratified and confirmed as true and correct and are hereby made a part of this Resolution.

Section 2. Implementation. The City Council of the City of Port St. Lucie, Florida, hereby authorizes the City Manager to enter into and execute the Right-of-Way Consent Agreement with FPL, in substantially the same form that is attached hereto and incorporated herein as Exhibit "A" to this Resolution, and such other documents necessary to implement the terms of said Agreement.

Section 3. Certified Copy to FPL. The City Clerk is hereby directed to send a certified copy of this Resolution to FPL Corporate Real Estate Department at P.O. Box 140.00, Juno Beach, Florida 33408-0420, and all other persons as directed by the City Council.

<u>Section 4.</u> <u>Conflict.</u> If any resolutions, or parts of resolutions, are in conflict herewith, this Resolution shall control to the extent of the conflicting provisions.

<u>Section 5.</u> <u>Severability</u>. The provisions of this Resolution are intended to be severable. If any part of this Resolution is determined to be void or is declared illegal, invalid, or unconstitutional by a Court of competent jurisdiction, the remainder of this Resolution shall remain in full force and effect.

<u>Section 6.</u> <u>Effective Date</u>. This Resolution shall become effective immediately upon adoption.
