

RESOLUTION 23-R__

A RESOLUTION OF THE CITY OF PORT ST. LUCIE, FLORIDA, AUTHORIZING THE FINAL ACCEPTANCE OF PUBLIC ROADWAY IMPROVEMENTS FOR SW COMMUNITY BOULEVARD AT RIVERLAND PARCEL A PHASE 2 (P19-193), CONSTRUCTED BY RIVERLAND DEVELOPMENT COMPANY, LLC; PROVIDING FOR CONFLICTS; PROVIDING FOR SEVERABILITY; AND PROVIDING AN EFFECTIVE DATE.

WHEREAS, Riverland Development Company, LLC, a Florida limited liability company (hereinafter, “Riverland”), an affiliated entity of the Developer for the Riverland/Kennedy DRI, has completed the construction of certain public roadway improvements, specifically SW Community Boulevard at Riverland Parcel A – Phase 2, the plat and construction plans (P19-193) for which have been previously approved on January 27, 2020, by the City Council of the City of Port St. Lucie via Resolution 20-R15; and

WHEREAS, the plat of SW Community Boulevard at Riverland Parcel A – Phase 2 was recorded on February 4, 2020, in Plat Book 85, at Pages 35-36, of the Public Records of St. Lucie County, Florida; and

WHEREAS, the public improvements constructed by Riverland for SW Community Boulevard consist of two lanes, with landscaping, from just South of Riverland Parcel A Main Entrance to just South of Riverland Paseo Park Entrance, together with the installation of sidewalk and drainage improvements that will support the ultimate design for the roadway’s future buildout (the “Road Improvements”), and

WHEREAS, the Road Improvements have been completed in substantial conformance with the approved plans and the delivery of a Bill of Sale from Riverland to the City of Port St. Lucie (“City”) shall serve to transfer the public roadway improvements located within the constructed portion of the SW Community Boulevard right-of-way; and

WHEREAS, pursuant to and in accordance with Section 156.150 of the City Code of Ordinances, Riverland has formally requested that the City accept the Road Improvements; and

WHEREAS, the City Engineer has caused the Road Improvements to be inspected and recommends that the City accept the Road Improvements so as to place said Road Improvements in the City’s ownership for responsibility and maintenance thereof; and

WHEREAS, the purpose of this Resolution is to formally accept ownership and maintenance responsibility of the completed Road Improvements.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY OF PORT ST. LUCIE, FLORIDA AS FOLLOWS, THAT:

RESOLUTION 23-R__

Section 1. Ratification of Recitals. The foregoing recitals are hereby ratified and confirmed as true and correct and are hereby made a part of this Resolution.

Section 2. Authorization. The City Council of the City of Port St. Lucie hereby authorizes the final acceptance of the completed construction of the SW Community Boulevard at Riverland Parcel A – Phase 2 public roadway improvements dedicated to the City so as to place said improvements under the ownership and maintenance obligation of the City.

Section 3. Conflict. If any resolutions or parts of any resolution, are in conflict herewith, this Resolution shall control to the extent of the conflicting provisions.

Section 4. Severability. The provisions of this Resolution are intended to be severable. If any part of this Resolution is determined to be void or is declared illegal, invalid, or unconstitutional by a Court of competent jurisdiction, the remainder of this Resolution shall remain in full force and effect.

Section 5. Effective Date. This Resolution shall become effective immediately upon adoption.
