

RESOLUTION NO. 23-

A RESOLUTION APPROVING THE PRELIMINARY AND FINAL PLAT FOR VERANO SOUTH PUD 1 - POD D PLAT - NO. 5 WITHIN THE CITY OF PORT ST. LUCIE, FLORIDA ON THE REQUEST OF VERANO DEVELOPMENT, LLC (P22-173); PROVIDING FOR CONFLICT; PROVIDING FOR SEVERABILITY; AND PROVIDING AN EFFECTIVE DATE.

WHEREAS, the City of Port St. Lucie, Florida has been requested by Daniel Sorrow, acting as agent for Verano Development LLC to approve the final plat with construction plans for Verano South PUD 1 - POD D - Plat No. 5, within the City of Port St. Lucie, Florida; and

WHEREAS, a performance guarantee covering the cost of the required improvements, as set forth in the mutually agreed upon cost estimate, has been submitted to the City; and,

WHEREAS, the plat conforms to Section 156, Port St. Lucie City Code, and meets all State requirements for such plats; and

WHEREAS, the Site Plan Review Committee, on June 8, 2022, recommended approval of the final plat (P22-173).

NOW, THEREFORE, BE IT RESOLVED BY THE CITY OF PORT ST. LUCIE, FLORIDA:

Section 1. Ratification of Recitals. The foregoing recitals are hereby ratified and confirmed as true and correct and are hereby made a part of this Resolution.

Section 2. That the City Council hereby approves the final plat for Verano South PUD 1 - POD D - Plat No. 5, within the City of Port St. Lucie, Florida, said plat being offered by Verano Development LLC as owner, and title holder of said property and as prepared by Gary A. Rager, P.S.M., as designated on the attached said Plat.

Section 3. That the Mayor and City Clerk of the City of Port St. Lucie, Florida, are hereby authorized to countersign the said plat so it may be properly recorded in the public records of St. Lucie County, Florida.

Section 4. Conflicts. If any Resolution, or parts of any Resolution, are in conflict herewith, this Resolution shall control to the extent of the conflicting provisions.

Section 5. Severability. The provisions of this Resolution are intended to be severable. If any part of this Resolution is determined to be void or is declared illegal, invalid, or

Section 6. Effective Date. This Resolution shall become effective immediately upon adoption.
