- Operate and maintain complex advanced treatment facilities with automatic control and telemetry systems.
- Operate and maintain pumps, equipment, and mechanical/automatic controls to maintain proper treatment.
- Regular and punctual attendance.
- Check treatment facilities routinely for proper operation and record daily meter readings.
- Check, read and change charts.
- Take wastewater samples for biological, bacterial, and chemical tests.
- Run chlorine residual tests.
- Prepare daily and monthly reports for submittal to regulatory agencies.
- Check complaints of malfunctions.
- Lubricate, grease, and maintain pumps, controls, meters, and related equipment.
- Perform planned preventative maintenance and scheduled operational duties.
- Perform data entry.
- Perform general housekeeping.
- Other duties as may be assigned.

- Knowledge of operation, maintenance, and repair procedures relating to wastewater treatment collection and effluent disposal facilities.
- Knowledge of the principles of biology, bacteriology, chemistry, hydraulics, and electricity.
- Knowledge of regulatory requirements relating to the operation of wastewater treatment facilities.
- Ability to work with computerized monitoring and tracking systems.
- Ability to understand and comply with oral and written instructions.
- Ability to read meters and charts accurately and ability to maintain records of operations.
- Ability to establish and maintain effective working relationships with employees and the public.
- Ability to focus on the positive in every situation.
- Ability to stay centered when challenged.
- Ability to model respect for individuals, teams, and the organization.
- Ability to establish and maintain the trust and confidence of the department and public.
- Ability to communicate effectively in writing and orally.
- Ability to work under pressure and meet deadlines.
- Ability to follow through with assigned tasks.

PHYSICAL DEMANDS
