Comments: Stormwater Utility Management System: I oppose this assessment. I challenge the methodology used to calculate the assessment. Who really benefits from this? Existing homeowners or future homeowners or Developers/Builders? An average home of 2280 square feet is not acceptable. Why should I pay the same rate as a square foot home that is larger than my home? I argue that the stormwater management system does not provide a special or peculiar benefit to my property that is different from the general community benefit. Did all local government follow procedures for enacting the assessment including proper notification and opportunity to object? Should this not be provided to voters on a ballot? If my property is worth less than my neighbor, then my tax responsibility should be less than my neighbors. Uniform appraisal is important. How can this cost be proportional to the benefit? Is this happening because of all the new building? That is not my responsibility, that should be the responsibility of

the developer/builder. This is not fair to the seniors who are on a set budget to pay for the expansions of developers/builders.

Nor, is this fair to younger families that are struggling every day and seniors as well as families could possibly lose their homes due to higher property taxes and non-ad valorem assessments due to over-building developers/builders. Developers/Builders should foot the majority of this and not pass it along to existing home owners. In my opinion, these decisions should be considered with compassion and not greed. Cut back on the spending and only do what is necessary and safe for the community.
