We are writing in response to the Lake Forest HOA demand that Grace Lutheran Church build a wall around our common property in order to build an Alzheimer's Day Care Center.

Grace has been very conscious and considerate of our neighbors in the location and design of the proposed care center which provides the abutting properties a view of the woods preserve rather than a cement wall.

We are a small congregation trying to reach out to our neighbors with a service that is drastically needed in our community rather than build a new sanctuary for our own use. The Church has been approached several times regarding trespassers parking in their lot while they walk through and fish. Unfortunately the practice continues to this Day. Good Morning Mr. Mayor,

My wife has had Alzheimer's Disease for 9 years, now. I was her sole caregiver for the first 7+ years. About 2 years ago I heard that St Andrew Lutheran Church had opened a Daycare Center for ALZ patients. I contacted them and had my wife, now of 57 years, placed on their waiting list. Several months later her name came up and she has been going there since February 2018. She loves it; they keep her busy and her mind active all day. I'll admit, I was starting to believe that I would need to place her in a residential Memory Care facility. The cost would have taken us bankrupt. I am very pleased with the services she receives at the Alzheimer's Community Care facility and that she is able to live at home with me. Having her in daycare allows me the time to care for our home and property without having to constantly be with her.

It is largely because of my wife Barbara that Grace Lutheran Church, where I serve as an Elder, decided that our newest Community Outreach would be to work closely with Alzheimer's Community Care to build a facility for their use during the day as a daycare facility for 30-40 more needy members of our Community.

We have planned for a Preserve; a buffer zone around the proposed new building which would be in the center of our 6 acres, well out of sight of our neighbors in Lake Forest. The building would be used as a Daycare facility; not a residential facility. No one would be staying overnight.

Building a wall next to the lake on the north side of the property would require clearing up to 10 feet on our side of the lake. The property owners there have not objected to the underbrush, trees and palmettos that they now look at across the lake. Building a wall would destroy that idyllic setting for

them and probably lower their property values which could ultimately adversely affect the City's tax base. With no wall they would be looking at exactly what they see now; Nature at its best.

Alzheimer's is a cruel disease. It is on the rise and facilities are needed to care for them. Please allow this project to go forward without an absolutely unnecessary and very costly wall. For our little Church and Alzheimer's Community Care to spend this extra money would ultimately just take away money for the care of our Community's most vulnerable.

I invite you to come this evening at 6:30 PM at Grace Lutheran Church, 555 SW Cashmere Blvd for an open meeting with the residents of Lake Forest to learn all about ACC and our proposed project.

Some of the community of Lake Forrest is requesting that if a building is constructed at Grace Lutheran for an Alzheimer daycare facility, that a wall also be built. Last week I attended a meeting between the church and some residents of Lake Forrest. A couple things became clear early: 1. Their desire for a wall had nothing to do with the building to be constructed. 2. Several of the residents that lived near where the wall would be constructed, definitely did not want the wall that was requested by the HOA President. Apparently, this is a gated community with a gate but lacking in perimeter security. People have parked on church property and walked to the lake behind which is shared by both. Some residents blame the Church and this is really why they want a wall. Unfortunately, people could still walk around the wall if they really wanted to.

Pastor Escher pledged to do more to try to run off people that park on church property. The daycare would bring more of a presence to the property for longer hours which could help alert police of trespassers. The expense of a wall seriously jeopardizes the building of the facility. As someone who has just had another member of my family diagnosed with Alzheimer's I know how important places like this are. As you are aware the Lake Forest HOA (LFHOA) has recommended a wall be constructed around the Grace Lutheran Church and the purposed Alzheimer/ Dementia (AD) day care facility which I am vehemently against as explained below.

IAW the Port Saint Lucie Zoning, which outlines policies of the City Comprehensive Plan to preserve, protect, improve the public health, safety, comfort, good order, appearance, convivence and to conserve, develop, utilize and protect the natural resources within the city.

I was privileged to review the aerial view of the present Grace property provided by Michelle Franklin, CFA – Saint Lucie County Property Appraiser and the establishment of a Nature Preserve designed by the PSL Planning and Zoning at the rear of the Grace property.

It is estimated that the 1200-foot wall would destroy approximately a 10-foot-wide construction right of way destroying an estimated 12,000 to 18,000 feet of old Florida vegetation or more and restrict the use of the Nature area without crossing onto the LFHOA property by walking around the wall.

The estimated cost of the wall is between \$140,000-\$200,000 and the destruction of the Florida vegetation and wildlife habitat would be catastrophic. Additionally, this cost would severely impact the construction cost of the purposed Alzheimer/ Dementia (AD) day care facility if not cancelling the project in total.

The wall is indeed in the code for planning and zoning. However, the PSL planning and zoning did not see a need for a wall around Grace Lutheran Church. The city of Port Saint Lucie has the power to grant an exception if the expectation is in the best interest of the community.

Alzheimer/ Dementia (AD) is a terrible disease which effect so many people. It is estimated that 1 out of 3 will suffer some type of Alzheimer/ Dementia (AD). It is our view that the wall would also lower the value of the homes near Grace Lutheran Church and take away the natural beauty of Mother Nature.

It is our hope and prayers that the city of Port St Lucie will see the need for this Alzheimer's unit and consider this wall a unnecessary expense to the church.
