A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF PORT ST. LUCIE, FLORIDA, APPROVING ARTWORK SUBMITTED BY SUNLIGHT COMMUNITY CHURCH OF PORT ST. LUCIE, INC, IN CONNECTION WITH THE APPROVAL OF A SITE PLAN AMENDMENT (PROJECT P19-097); PROVIDING FOR CONFLICTS; PROVIDING FOR SERVABILITY; AND PROVIDING AN EFFECTIVE DATE.

WHEREAS, Chapter 162 of the City's Code of Ordinances requires certain public art requirements to be met when certain new improvements are constructed; and

WHEREAS, on October 28, 2019, City Council approved a site plan amendment application, which triggered the City's public art requirements, (Project No. P19-097) that was submitted by Sunlight Community Church of Port St. Lucie, Inc. It is located at 477 SW Cashmere Boulevard; and,

WHEREAS, Section 162.09 of the City's Code of Ordinances allows the developer to provide permanent public artwork as part of its development project in order to comply with the City's public art requirements, and Sunlight Community Church of Port St. Lucie, Inc has proposed to construct metal-constructed lettering spelling out "SUNL_GHT" for their Public Art application for on-site artwork. The lettering will stand 60 inches tall, and students will be encouraged to stand in place of the "I" to spell out the word Sunlight, and is attached as Exhibit "A"; and

WHEREAS, Section 162.05 of the City's Code of Ordinances sets forth the selection criteria for sites and public art; and

WHEREAS, on September 20, 2021, the Public Art Advisory Board held a hearing and completed its review of the Proposed Artwork for compliance with Chapter 162 of the City's Code of Ordinances; and

WHEREAS, the Public Art Advisory Board found the Proposed Artwork consistent with Chapter 162 of the City's Code of Ordinances and recommended that the City Council approve the Proposed Artwork; and

WHEREAS, City Council held a hearing on October 11, 2021 to consider the Proposed Artwork; and

WHEREAS, the City Council has considered the Proposed Artwork and all evidence and testimony submitted into the record relating to the Proposed Artwork and has determined that the

approval of the Proposed Artwork is consistent with Chapter 162 of the City's Code of Ordinances.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY OF PORT ST. LUCIE, FLORIDA:

<u>Section 1.</u> <u>Ratification of Recitals</u>. The foregoing recitals are hereby ratified and confirmed as true and correct and are hereby made a part of this Resolution.

<u>Section 2.</u> That the City Council accepts the recommendation of the Public Art Advisory Board and hereby approves the proposed artwork.

<u>Section 3</u>. <u>Conflicts.</u> If any Resolution, or parts of any Resolution, are in conflict herewith, this Resolution shall control to the extent of the conflicting provisions.

<u>Section 4</u>. <u>Severability</u>. The provisions of this Resolution are intended to be severable. If any part of this Resolution is determined to be void or is declared illegal, invalid, or unconstitutional by a Court of competent jurisdiction, the remainder of this Resolution shall remain in full force and effect.

<u>Section 5.</u> <u>Effective Date</u>. This Resolution shall become effective immediately upon adoption.
