WITNESSETH: Grantor, for and in consideration of the sum of TEN DOLLARS and other good and valuable considerations to Grantor in hand paid by Grantee, the receipt whereof is hereby acknowledged, has granted, bargained, and sold to Grantee, and Grantee's heirs and assigns forever, the property described land, situate, lying and being in **ST. 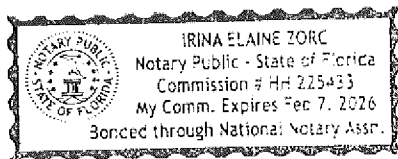

Being a portion of OST-21 of the plat of TRADITION PLAT NO. 18, as recorded in Plat Book 44, Page 30, Public Records of St. Lucie County, Florida, and a parcel of land recorded in Official Records Book 2700, Page 109, all lying in Section 4, Township 37 South, Range 39 East being more particularly described as follows:

Commence at the Northeast corner of said Section 4; thence $S00^{\circ}35'12''W$, along the East line of said Section 4, a distance of 824.14 feet; thence $N89^{\circ}24'48''W$ a distance of 198.19 feet to the Northeast corner of said OST-21; thence $S00^{\circ}35'12''W$, along the East line of said OST-21, a distance of 165.51 feet to the POINT OF BEGINNING of the following described parcel;

Thence continue $S00^{\circ}35'12''W$ a distance of 259.50 feet; thence $S18^{\circ}21'56''E$ a distance of 32.12 feet to the intersection with a non-tangent curve concave to the southwest, having a radius of 45.00 feet, the chord of which bears $N53^{\circ}53'22''W$; thence northwesterly along the arc of said curve, a distance of 55.80 feet through a central angle of $71^{\circ}02'52''$; thence $N89^{\circ}24'48''W$ a distance of 63.77 feet to the beginning of a curve concave to the north having a radius of 455.00 feet; thence westerly along the arc of said curve a distance of 22.16 feet through a central angle of $02^{\circ}47'26''$ to the point of compound curvature with a curve concave to the north, having a radius of 100.00 feet; thence westerly along the arc of said curve, a distance 46.84 feet through a central angle of $26^{\circ}50'21''$; thence $N59^{\circ}47'01''W$ a distance of 3.56 feet to the beginning of a curve concave to the south having a radius of 100.00 feet; thence westerly along the arc of said curve a distance of 29.45 feet through a central angle of $16^{\circ}52'15''$ to the point of reverse curvature with a curve concave to the northeast, having a radius of 440.00 feet; thence northwesterly along the arc of said curve a distance of 153.54 feet, through a central angle of $19^{\circ}59'35''$; thence $N56^{\circ}39'41''W$ a distance of 634.75 feet to the beginning of a curve concave to the northeast having a radius of 440.00 feet; thence northwesterly along the arc of said curve, a distance of 229.87 feet through a central angle of $29^{\circ}55'59''$; thence $N26^{\circ}43'42''W$ a distance of 17.93 feet to the beginning of a curve concave to the east having a radius of 195.00 feet; thence northerly along the arc of said curve a distance of 46.08 feet through a central angle of $13^{\circ}32'19''$ to the point of reverse curvature with a curve concave to the west, having a radius of 40.00 feet; thence northerly along the arc of said curve a distance of 9.45 feet, through a central angle of $13^{\circ}32'19''$; thence $N26^{\circ}43'42''W$ a distance of 62.49 feet; thence $N63^{\circ}16'18''E$ a distance of 465.78 feet; thence $S71^{\circ}43'42''E$ a distance of 35.34 feet; thence $S26^{\circ}43'42''E$ a distance of 387.39 feet to the beginning of a curve concave to the northeast having a radius of 600.00 feet; thence southeasterly along the arc of said curve a distance of 574.83 feet through a central angle of $54^{\circ}53'31''$ to the POINT OF BEGINNING.
