Under discussion, Vice Mayor Caraballo explained the funds awarded to the City Police Department, and Councilwoman Morgan moved to approve Item 13a). Vice Mayor Caraballo seconded the motion, which passed unanimously by voice vote.

14. City Manager's Report

City Manager Merejo discussed four memorandums that would be sent to the City Council about City-wide Traffic Accident Enforcement, the proposed City University Ambassadors Program, Becker Road Completion Update, and the reopening of Skate City Whispering Pines Park. He thanked the City Council for

supporting the land swap with St. Lucie County which was recently approved. City Manager Merejo discussed the potential traffic issues at the intersection of Discovery Way and Community Blvd.

15. Councilmembers Report on Committee Assignments

Councilwoman Morgan agreed with City Manager Merejo regarding addressing the traffic issues at Discovery Way and Community Blvd. She thanked Chief Niemczyk and the Port St. Lucie Police Department for enforcing aggressive driving and speeding. She indicated she would like a future discussion on the Cameo Site and Golf Carts/Motorized Vehicles. Councilwoman Morgan stated she attended the St. Lucie County and Florida Power and Light update Luncheon, the St. Lucie County Fire District Board Meeting, the City of Port St. Lucie Employee Appreciation Luncheon, and the Swearing in Ceremony of Richard Del Toro, St. Lucie County Sheriff. She added that she met with County Commissioners Fowler, Lowry, and Clasby and the County Administrator George Landry. Councilwoman Morgan stated she attended Deputy City Manager David Graham's Retirement party.

Councilman Pickett congratulated Chief of Police Niemczyk for the traffic enforcement. He stated he hosted Coffee with the Council and attended the Treasure Coast League of Cities Holiday Luncheon, Sheriff Richard Del Toro's Swearing-in Ceremony, Treasure Coast Council of Local Governments, and Deputy City Manager David Graham's Retirement party.

Vice Mayor Caraballo stated that she visited the RP Funding Center and attended the Treasure Coast National League of Cities Annual Meeting and Holiday Luncheon. She stated she attended the Swearing-in Ceremony for Richard Del Toro, St. Lucie County Sheriff, and the Orientation for St. Lucie Leadership Class. Vice Mayor Caraballo gave kudos to the City of Port St. Lucie Police Department.

Vice Mayor Caraballo asked the City Manager what future City Council Meeting the Solid Waste Report Review would be discussed, to which Assistant City Manager Teresa Lamar-Sarno stated there were currently one-on-ones being scheduled to discuss the Cameo Site and provide some recommended changes. Assistant City Manager Lamar-Sarno indicated that Raftelis completed their report and analysis regarding the City providing Solid Waste Services. She confirmed that she would be scheduling one-on-ones with the City Council to provide their update. Assistant City Manager Lamar-Sarno addressed Councilwoman Morgan's comment regarding Golf Carts in the City and confirmed that Public Works continued to work on the matter and hoped to have an update to the Council at this year's Winter Workshop. Vice Mayor Caraballo asked if there were Council Meetings scheduled for the Cameo or Raftelis Update, to which Assistant City Manager Lamar-Sarno responded in the negative. Vice Mayor Caraballo stated that the dialogue should take place at the dais so that the

Council can provide concrete decisions and directions to the City Manager's Office. She asked the City Manager's Office to have a projected date for Council Meetings following the one-on-ones with the City Council. Vice Mayor Caraballo expressed concern over processes and policies that she felt were falling through the cracks and stated Bulk Waste was a huge issue.

Mayor Martin asked if these topics could be discussed at the Winter Workshop.

Councilwoman Morgan inquired if there was a way to have an informal meeting for these topics. Vice Mayor Caraballo was open to having an informal meeting.

City Manager Merejo indicated the issue of providing the City Council with future meeting dates for the one-on-ones that are scheduled is that sometimes there are issues that may require additional time to research and would have to change the Council Meeting date.

Vice Mayor Caraballo suggested a City Manager's Weekly report and if there is a need to change something then notify the Council through those means.

It was the consensus that the City Council hold an Informal Meeting on or before February 18, 2025, to discuss the Raftelis Consulting Firm Solid Waste Update/Report and the City's Cameo Site.

Councilman Bonna wished everyone a happy new year and stated he attended the Swearing-in Ceremony for the Constitutional Officers, Sheriff Richard Del Toro, and Sheriff John Budensiek. He reported he attended a nominating committee for the Treasure Coast Regional Planning Council and announced he would be the Chairman of the Treasure Coast Regional Planning Council.

Mayor Martin announced she attended the Swearing-in Ceremony for Richard Del Toro. She indicated the need to focus on the Community Blvd. and Discovery Way intersection.
