ORDINANCE 20-

AN ORDINANCE OF THE CITY OF PORT ST. LUCIE, FLORIDA, REZONING 0.46-ACRES OF PROPERTY, LOCATED ON THE NORTH SIDE OF SW ABODE AVENUE AND EAST OF SW PORT ST. LUCIE BOULEVARD, FROM PROFESSIONAL (P) ZONING DISTRICT TO SINGLE-FAMILY RESIDENTIAL (RS-2) ZONING DISTRICT FOR PROPERTY LEGALLY DESCRIBED AS PORT ST. LUCIE-SECTION 33- BLOCK 2325 LOTS 30 AND 31 (P20-210); PROVIDING FOR CONFLICT; PROVIDING FOR SEVERABILITY; AND PROVIDING FOR AN EFFECTIVE DATE.

WHEREAS, the City of Port St. Lucie, Florida ("City"), has initiated a rezoning of 0.46-acres of property located on the north side of SW Abode Avenue and East of SW Port St. Lucie Boulevard, and within the City of Port St. Lucie, from the Professional (P) Zoning District to Single-Family Residential (RS-2) Zoning District; and

WHEREAS, the proposed zoning is consistent with all applicable elements of the City's adopted Comprehensive Plan and complies with the City's Code of Ordinances; and

WHEREAS, the City of Port St. Lucie Planning and Zoning Board held a public hearing on November 17, 2020 to consider the rezoning application (P20-210), notice of said hearing to adjoining property owners for a radius of seven hundred and fifty (750) feet having been given and advertising of public hearing having been made; and

WHEREAS, the City Council held a public hearing on December 14, 2020, to consider the rezoning application (P20-210), advertising of the public hearing having been made; and

WHEREAS, the City Council has considered the rezoning application (P20-210) based on substantial and competent evidence and the City Council has determined to rezone the property legally described as Port St. Lucie-Section 33- Block 2325 Lots 30 and 31 as recorded in Plat Book 15, Pages 1, 1A through 1V, of the Public Records of St. Lucie County, as provided herein.

NOW, THEREFORE, THE CITY OF PORT ST. LUCIE HEREBY ORDAINS:

<u>Section 1.</u> <u>Ratification of Recitals.</u> The City Council of the City of Port St. Lucie, Florida, hereby adopts and ratifies those matters as set forth in the foregoing recitals.

Section 2. That the property located on the north side of SW Abode Avenue and east of SW Port St. Lucie Boulevard, and legally described as Port St. Lucie-Section 33- Block 2325 Lots 30 and 31, recorded in Plat Book 15, Pages 1, 1A through 1V, of the Public Records of St. Lucie County, be rezoned from the Professional (P) Zoning District to Single-Family Residential (RS-2) Zoning District.

<u>Section 3.</u> <u>Conflict.</u> If any ordinance, or parts of ordinances, or if any sections, or parts of sections, of the ordinances of the City of Port St. Lucie, Florida, are in conflict herewith, this Ordinance shall control to the extent of the conflicting provisions.

Section 4. Severability. The provisions of this Ordinance are intended to be severable. If any provision of this Ordinance is determined to be void or is declared illegal, invalid, or unconstitutional by a Court of competent jurisdiction, the remainder of this Ordinance shall remain in full force and effect.

Section 5. Effective Date. That this Ordinance shall become effective ten (10) days after its final adoption.
