I am writing to register my objection to the building of the proposed Wireless Communication Tower on the property adjacent to the eastern boundary of the St Lucie West Country Club Estates community, and to the Special Exception Use Application that is being heard at the July 26, 2021 at the 6:30 meeting of the City of Port St. Lucie Planning and Zoning Board. I am a property owner and resident of this community.

You, the City Council claims that only 111 letters regarding this matter were sent to the Council stating that they then assume that this is not an issue for 75% of the residents who have not weighed in, and "that many residents favor the tower, but are intimidated to say so." This is not True. You know that in the Rainy season a lot of residents are out of town. The residents that live in our community here in Country Club Estates are **not** in favor of the Cell Tower, especially of the 5G antenna In fact were are against it. We are afraid of our health so near to our home, the noise that cause the ringing in our ears who have sensitive hearing as I do (it happens to me every time I'm in distance of a 5G tower, The reception of our cell phones and computers that are blocked near the tower, and the damage to our property values.
