A RESOLUTION APPROVING AND ACCEPTING THE PRELIMINARY SUBDIVISION PLAT WITH CONSTRUCTION PLANS FOR VERANO SOUTH POD G - PLAT NO. 6 WITHIN THE CITY OF PORT ST.
