A RESOLUTION APPROVING AND ACCEPTING THE FINAL PLAT AND CONSTRUCTION PLANS FOR HERON PRESERVE AT TRADITION PHASE 2B WITHIN THE CITY OF PORT ST. LUCIE, FLORIDA ON THE REQUEST OF PULTE HOME COMPANY, LLC (P22-292); PROVIDING FOR CONFLICTS; PROVIDING FOR SEVERABILITY; AND PROVIDING AN EFFECTIVE DATE.

WHEREAS, the City of Port St. Lucie, Florida has been requested by Pulte Home Company, LLC, the owner and developer, to approve the final plat and construction plans for Heron Preserve at Tradition Phase 2B, within the City of Port St. Lucie, Florida; and

WHEREAS, there are private roads and drainage facilities to be constructed within the platted area by the developer; and

That the City Council hereby approves the final plat and construction plans for Heron Preserve at Tradition Phase 2B, within the City of Port St. Lucie, Florida, said final plat being offered by Pulte Home Company, LLC as owner and title holder of said property and as prepared by David P. Lindley of Caulfield and Wheeler, Inc., as designated on the attached said Plat.

<u>Section 3</u>. That the Mayor and City Clerk of the City of Port St. Lucie, Florida, are hereby authorized to countersign the said plat so it may be properly recorded in the public records of St. Lucie County, Florida.

<u>Section 4.</u> <u>Conflict</u>. If any resolutions, or parts of resolutions, are in conflict herewith, this Resolution shall control to the extent of the conflicting provisions.
