NOW THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the parties do hereby agree as follows:

- 1A. The following modifications to the Scope of Work are as follows:
  - a.) Add new pay items to relocate existing palm and oak trees.
  - b.) Add new pay item to install CIPP Lining in existing 36" HDPE to outfall at Kingsway.
  - c.) Add new pay items for WM and LPFM service transfers.
  - d.) Add new pay items to include revised plans for Chapman drainage modifications.
  - e.) Add new lump sum pay item for S-113 drainage and sewer modifications.

- 1B. The additional costs associated with the new Scope of Work:
  - a.) Relocate Live Oak 8 each at \$587.00 each for a total of \$4,696.00 Relocate Sabal Palm 25 each at \$323.00 for a total of \$8,075.00
  - b.) Bypass pumping 1 lump sum at \$6,344.00 CIPP Lining 36" HDPE Drainage Pipe 175 LF at \$191.00 for a total of \$33,425.00
  - c.) WM & LPFM Service Transfers 137 each at \$525.00 for a total of \$71,925.00
  - d.) Modify Drainage Structures 8 each at \$721.00 for a total of \$5,768.00 WM & LPFM Service Adjustments 2 each at \$524.00 for a total of \$1,048.00
  - e.) Sewer Adjustments 1 lump sum at \$5,719.00
