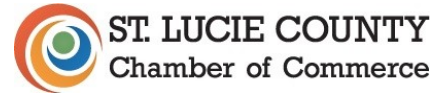

Small Business Assistance Program

The Mission: The Small Business Assistance Program of the St. Lucie County Chamber of Commerce helps businesses navigate the regulatory process. Our purpose is to minimize cost, risk and time delays when local business seeks to purchase, build, expand, relocate or repurpose commercial space.

Contact: The first six months of the year have been consistently busy as we often see new starts ups in the first quarter annually. This is expected. We are continuing to see fewer seekers of “schools” and day cares which is promising as we have made a concerted effort to get the word out that physical space for these two ventures is not as easy as one might hope to bring into compliance. We have seen more of an uptick in people seeking commercial space and at our last PSL “Before You Sign the Lease” event all attendees were actually seeking physical space. Our first similar event at the county was quite successful and reminded us that most people are unaware of the jurisdictions they are in, may potentially be in and it very often changes anyway. So this has made it easier to cast a wider net in accessing potential business owners. We had approximately forty-two unique visits with program users this calendar year. We are finding many contacts involve application processes, this includes state, federal and local licensing. We have now requested testimonials, but not surprisingly, few responded but we have included them here.

Types of Businesses: At the beginning of the year we saw a lot of event sector businesses. These types of businesses have struggled historically due to a lack of corporate entities in our area. Non-profits seem to be the main drivers of events in St. Lucie County. In the second quarter we have seen an uptick in businesses selling goods. Whether it foods, home-made products and even a couple of small markets.

Insights: We have seen so few missteps now that our outreach has become more aggressive. The clientele seems to have gotten smarter about knowing there will be a process to opening commercial space and fewer attempt to do it without seeking some outside advices or help whether its with the jurisdiction itself or with a group or agency such as ours.

Outreach: We are now doing the “Before You Sign The Lease” workshop in both the City of PSL and St. Lucie County. We had a good turn out of about 10 attendees at our first county workshop. Our second workshop is scheduled for August and marketing has already begun. The good news about outreach at multiple jurisdiction as noted above, most think they may be in one and find out they are in another but we are covering them both.

Additionally, we continue to outreach to realtors through our quarterly Community 101 program. Attendees at this class typically specialize in residential real estate which is the point

as we are trying to reach those who may occasionally work in commercial real estate rather than those who specialize in it. We are also hoping to educate these realtors on the importance in referring potential commercial clients they may come in contact with to us.

ADDITIONAL INFORMATION (Previously Included) It is important to note, as part of this program, the Chamber procures the services of the Size-Up program at the cost of \$5000.00 per year. This program provides services to prospective businesses in the form of location identification, procurement services, advertising opportunities, competitor information, expected wages and much more. The cost for this service comes directly out of the chamber's budget for these programs. Going forward, we will be looking to identify more unique ways in which we can assist small businesses. We feel the Size-up program information is duplicative in many ways and is rarely used by our clientele.

We have identified a couple of ways in which we feel the \$5000.00 may be of better use to the small businesses of St. Lucie County.

Primarily, we would like to establish a data base of certificate of occupancies or business tax receipts for all known commercial spaces in operation for the entire county. This would allow us to help small business identify optimal space or the obstacles to potential spaces without burdening staff in any jurisdiction. The knowledge of the use of record could be a potential cost savor to all parties resulting in millions of dollars a year.

Additionally, if we could secure additional funds and bring in our partners from all jurisdictions, we would like to establish some fillable forms that would be acceptable and easy to understand for some processes. Some items executed by contractors, architects or engineers may be templated for their convenience and assisted with by my staff. This would require development and most of all acceptance and a partnership/relationship with professionals that would carry a cost. However, it would be a service that would be well worth the investment for small business in St. Lucie County.

UPDATE: We have been given some tools to access the information necessary to identify what a commercial space may have been last legitimately used for and this is helping tremendously.

NEXT: We would like to be able to access the last filed Life Safety plan for each location.
