
NOTICE OF NEW AND UPDATED IMPACT FEES For All Unincorporated and Incorporated Areas of St. Lucie County, Florida

At the April 19, 2022 meeting of the Board of County Commissioners of St. Lucie County, Florida, the Board adopted Ordinance No. 2022-008, which established new and updated parks impact fees in all unincorporated and incorporated areas of St. Lucie County. The new parks impact fee benefit districts for the unincorporated and incorporated areas of the county are shown in the map below.



These impact fees are imposed on all new construction that applies for a building permit on or after the dates specified below and will fund capital improvements and additions to parks and recreation infrastructure needed to serve new growth. The impact fees will be due and collected as a condition of issuance of a building permit at the rates specified below.

The following impact fee rates will be effective on October 1, 2022:*
