A RESOLUTION APPROVING A PRELIMINARY AND FINAL PLAT FOR TRADITION SG-10 WITHIN THE CITY OF PORT ST. LUCIE, FLORIDA ON THE REQUEST OF MATTAMY PALM BEACH, LLC, AND THE CITY OF PORT ST LUCIE PROVIDING FOR CONFLICT; PROVIDING FOR SEVERABILITY; AND PROVIDING AN EFFECTIVE DATE (P22-134).

WHEREAS, the City of Port St. Lucie, Florida has been requested by Kimley-Horn, acting as agent for Mattamy Palm Beach, LLC, and the City of Port St. Lucie, owners, to approve a preliminary and final plat for Tradition SG-10, within the City of Port St. Lucie, Florida; and

<u>Section 5</u>. <u>Severability</u>. The provisions of this Resolution are intended to be severable. If any part of this Resolution is determined to be void or is declared illegal, invalid, or unconstitutional by a Court of competent jurisdiction, the remainder of this Resolution shall remain in full force and effect.
