A RESOLUTION APPROVING THE PRELIMINARY AND FINAL PLAT FOR RIVERLAND PARCEL A - PLAT ONE - REPLAT NO. 1 WITHIN THE CITY OF PORT ST. LUCIE, FLORIDA ON THE REQUEST OF RIVERLAND ASSOCIATES I, LLLP (P20-229); PROVIDING FOR CONFLICT; PROVIDING FOR SEVERABILITY; AND PROVIDING AN EFFECTIVE DATE.

WHEREAS, the City of Port St. Lucie, Florida has been requested by Michael Fogarty, P.E., acting as agent for Riverland Associates I, LLLP to approve the preliminary and final plat for Riverland Parcel A - Plat One - Replat No. 1, within the City of Port St. Lucie, Florida; and

<u>Section 1.</u> <u>Ratification of Recitals</u>. The foregoing recitals are hereby ratified and confirmed as true and correct and are hereby made a part of this Resolution.
