## ELEVENTH AMENDMENT TO INTERLOCAL AGREEMENT (TRAFFIC CONTROL AND SECURITY - ST. LUCIE COUNTY SPORTS COMPLEX) C88-06-074

THIS ELEVENTH AMENDMENT TO INTERLOCAL AGREEMENT dated this

\_\_\_\_\_day of \_\_\_\_\_\_\_, 2025, by and between ST. LUCIE COUNTY, a political subdivision of the State of Florida, hereinafter referred to as "County," and the CITY OF PORT ST. LUCIE, a Florida municipal corporation, hereinafter referred to as "City."

## WITNESSETH:

WHEREAS, on June 21, 1988, the parties entered into an Interlocal Agreement, hereinafter referred to as the "Agreement," which was recorded in Official Records Book 593, pages 1800 through 1802, of the public records of St. Lucie County, Florida, which provided for the City to furnish off-duty City police officers to the County to perform traffic control and security during scheduled events at the St. Lucie County Sports Complex.

**WHEREAS,** the parties subsequently amended the Agreement on June 20, 1989, May 19, 1998, March 24, 2000, May 10, 2000, January 1, 2002, December 11, 2005, January 1, 2008, March 1, 2009, February 25, 2021 and June 6, 2022 to reflect increases in the hourly wages paid to the City's police officers and supervisors, apply a 3-hour minimum for each officer, and apply an administrative fee.

**WHEREAS,** the City intends to further increase the hourly wage paid to its police officers and supervisors effective December 1, 2024; and,

**WHEREAS,** the parties desire to further amend the Agreement to reflect the planned increase in the hourly wage for the City's police officers and supervisors, with no change to the administrative fee for officers and supervisors.

**NOW, THEREFORE,** in consideration of the premises and undertakings contained herein, the parties hereto agree to amend the Agreement as follows:

- 1. Paragraph 3 shall be amended to read as follows:
  - 3. In return for the faithful performance of the services provided in accordance with the terms and conditions of this Agreement, the County agrees to pay to the City sixty-five and 00/100 (\$65.00) dollars for each hour of service provided to the County by a police officer (\$65.00 x 3-hour minimum = \$195.00) and seventy and 00/100 (\$70.00) dollars for each hour of service provided to the County by a police supervisor (\$70.00 x 3-hour minimum = \$210.00) and seventy-four and 50/100 (\$74.50) dollars for each hour of service provided to the County by a police lieutenant (\$74.50 x 3-hour min = \$223.50). The rates set forth herein include a six and 00/100 (\$6.00) dollar administrative fee.

In addition, on the twelve (12) City-recognized holidays, the County agrees to pay to the City seventy-five and 00/100 (\$75.00) dollars for each hour of service provided to the County by a police officer (\$75.00 x 3-hour minimum = \$225.000) and eighty and 00/100 (\$80.00) dollars for each hour of service provided to the County by a police supervisor (\$80.00 x 3-hour minimum = \$240.00) and eighty-four and 50/100 (\$84.50) dollars for each hour of service provided to the County by a police lieutenant (\$84.50 x 3- hour min = \$253.50). The holiday rates set forth herein include a six and 00/100 (\$6.00) dollar administrative fee.

The twelve (12) City-recognized holidays are:

- Independence Day
- Labor Day
- Veteran's Day
- Thanksgiving Day
- Day After Thanksgiving
- Christmas Eve
- Christmas Day

- 2. The rate increase provided herein shall be effective December 1, 2024.

3. Paragraph 8 of the original agreement shall be amended to read as follows:
