The Children's Services Council has been in existence in St. Lucie County since 1990, supporting programs in both Port St. Lucie and Fort Pierce. As the City of Port St. Lucie has grown, the CSC has working to also expand the services and resources available within the city limits and to educate the residents about the programs available to them. While some of the programs who receive support from the Children's Services Council may be well known, the actual work of the CSC is not. Many of the organizations and most vital programs and resources that have helped families survive the difficulties of the past two years would not have been able to sustain without the support of CSC and their efforts to help local families.

At the start of COVID, as schools and offices began to shut down, the programs funded by CSC quickly realized that some families would not be able to manage the new virtual school requirements. Working with afterschool and summer program providers, CSC was able to invest funding to allow those organizations to open their doors for "Learning Launchpads" — or virtual learning hubs — offering 450 students a safe place to complete their virtual school work while still allowing their parents to work. This model was expanded by an additional 300 seats for an especially important group of parents deemed essential workers, who were needed to continue serving the community.

Additionally, as part of a local funding collaborative, CSC was able to purchase PPE for funded program partners as well as the families they were serving. Through this collaborative group, CSC was also able to provide funding for agencies that excelled in providing basic needs to our community – food, diapers, etc. as well as providing for agency purchases of technology equipment that allowed them to transition to tele-health services. During the peak of the crisis, CSC funded more than \$200,000 in PPE and related items that also leveraged an additional \$200,000 from other funders.

COVID was also hard on our local eateries who relied on families to dine-in or pick up food. In an effort to encourage continued patronage of small businesses, CSC partnered with the Chamber of Commerce to organize the Small Business Challenge. Participating businesses, nominated by the Chamber, were matched with one of CSC's non-profit partners for a specific challenge day each week. On that day, CSC donated an amount equal to the selected business' revenue (up to \$1,000). Anecdotally, we know that some of these challenge days kept these small businesses afloat during their most difficult times. The challenge is still happening one day each month and supporting restaurants throughout our community.

Outside of the COVID response that was directed to families in our community, the Children's Services Council has also worked directly with the City of Port St. Lucie to expand our St. Lucie Reads initiative. Several public-facing City departments host Little Libraries, where members of the public can pick up and/or read a book with their child while waiting for city staff. With the help of the CSC Community Engagement Coordinator, several city departments have also hosted book-drives to help supply the Little Libraries within their departments.

Newly in 2021, CSC also became a part of City University, offering participants a close look at the inner workings of the Children's Services Council and how the needs of the community were met through our funded program partners.
