

RESOLUTION 26-R__

A RESOLUTION OF THE CITY OF PORT ST. LUCIE, FLORIDA, AUTHORIZING THE FINAL ACCEPTANCE OF PUBLIC ROADWAY IMPROVEMENTS FOR CROSTOWN PARKWAY, 2B (P22-169), CONSTRUCTED BY OAK RIDGE RANCHES, LLC PROVIDING FOR CONFLICTS; PROVIDING FOR SEVERABILITY; AND PROVIDING AN EFFECTIVE DATE.

WHEREAS, Oak Ridge Ranches, LLC, a Florida limited liability company (hereinafter, “Oak Ridge”), an affiliated entity of the Developer for the Verano Development, has completed the construction of certain public roadway improvements, specifically Crosstown Parkway extension, phase 2B, the plat and construction plans (P22-169) for which have been previously approved on April 22, 2023, by the City Council of the City of Port St. Lucie via Resolution 23-R51; and

WHEREAS, the plat of Crosstown Parkway, 2B was recorded on January 17, 2025, in Plat Book 131, at Pages 1 - 4, of the Public Records of St. Lucie County, Florida; and

WHEREAS, the public improvements constructed by Oak Ridge for Crosstown Parkway, 2B consist of four (4) lanes, with landscaping, from Sundance Vista Boulevard west to Range Line Road, together with the installation of sidewalk and drainage improvements that will support the ultimate design for the roadway’s future buildout (the “Road Improvements”), and

WHEREAS, the Road Improvements have been completed in substantial conformance with the approved plans and the delivery of a Bill of Sale from Oak Ridge Ranches, LLC to the City of Port St. Lucie (“City”) shall serve to transfer the public roadway improvements located within the constructed portion of the Crosstown Parkway, 2B right-of-way; and

WHEREAS, pursuant to and in accordance with Section 156.150 of the City Code of Ordinances, Oak Ridge has formally requested that the City accept the Road Improvements; and

WHEREAS, the City Engineer has caused the Road Improvements to be inspected and recommends that the City accept the Road Improvements so as to place said Road Improvements in the City’s ownership for responsibility and maintenance thereof; and

WHEREAS, the purpose of this Resolution is to formally accept ownership and maintenance responsibility of the completed Road Improvements.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY OF PORT ST. LUCIE, FLORIDA AS FOLLOWS, THAT:

Section 1. Ratification of Recitals. The foregoing recitals are hereby ratified and confirmed as true and correct and are hereby made a part of this Resolution.

Section 2. Authorization. The City Council of the City of Port St. Lucie hereby authorizes the final acceptance of the completed construction of the Crosstown Parkway, 2B public roadway improvements dedicated to the City so as to place said improvements under the ownership and maintenance obligation of the City.

Section 3. Conflict. If any resolutions or parts of any resolution, are in conflict herewith, this Resolution shall control to the extent of the conflicting provisions.

Section 4. Severability. The provisions of this Resolution are intended to be severable. If any part of this Resolution is determined to be void or is declared illegal, invalid, or unconstitutional by a Court of competent jurisdiction, the remainder of this Resolution shall remain in full force and effect.

Section 5. Effective Date. This Resolution shall become effective immediately upon adoption.
