- Engage in the business or act in the capacity of a contractor or advertise himself/herself or a business organization as available to engage in the business or act in the capacity of a contractor without being duly registered or certified or the holder of a certificate of competency;
- Operate a business organization engaged in contracting after 60 days following the termination of its only qualifying agent without designating another primary qualifying agent;
- Commence or perform work for which a building permit is required per Part IV of Chapter 553 without such building permits being in affect;
- Willfully or deliberately disregard or violate any municipal ordinance relating to uncertified or unregistered contractor;
- Act in the capacity of a contractor different from the scope of work for which the contractor is certified to perform;
- Failed to secure required inspections;
- Willfully or deliberately obtaining or attempting to obtain a permit for an entity unregistered or unlicensed;
- Practice contracting unless the person is certified or registered (ELECTRICAL)
- Use the name or title "electrical contractor" or "alarm system contractor" or words to that effect, or advertise himself or herself or a business organization as available to practice electrical or alarm system contracting, when the person is not then the holder of a valid certification or registration issued pursuant to this part.

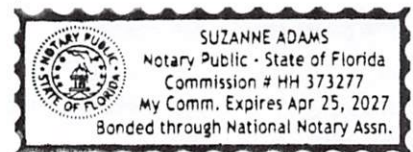

## OFFICIAL DEMAND LETTER REQUIREMENTS

---

Per Florida State Statute 489.126:

If the job meets one of the following criteria, the complainant must send the contractor a Demand Letter:

- More than 10% of the total cost of the job was issued to the contractor via a deposit and no permits were applied for within 30 days (if applicable), or
- No work has been started within 90 days after the permits were issued (if permits were required).

The Demand Letter must be mailed to:

- The address on the contract
  - In the absence of an address being listed on the contract, the letter must be sent to the address listed with the Department of Business and Professional Regulation (DBPR) or the local licensing construction industry licensing board.

The letter must request for the contractor to:

- Apply for necessary permits
- Start the work.
- Request a refund

The letter must be sent via certified mail. Keep the receipt and Domestic Return Receipt/Tracking Number for your records.

**Florida Statutes 489.128 Contracts entered into by unlicensed contractors unenforceable.**

As a matter of public policy, contracts entered into on or after October 1, 1990, by an unlicensed contractor shall be unenforceable in law or in equity by the unlicensed contractor.

A contractor shall be considered unlicensed if the contractor was unlicensed on the effective date of the original contract for the work

July 1<sup>st</sup> 2025, the City of Port St. Lucie no longer recognizes Certificate of Competencies and only state-certified licenses are recognized. Hammerhead Marine Construction/Dennis Respol's license is inactive due to this reason.

July 10<sup>th</sup> 2025 the city of Port St. Lucie held a disciplinary hearing against Hammerhead Marine Construction/Dennis Respol for disregarding and violating applicable state or local building code, regulation or law with the board suspending the company's **permitting privileges in the city of Port St. Lucie for 365 days**

August 4<sup>th</sup> 2025 the state of Florida determined that **Dennis Respol was not licensed by the Department of Business and Professional Regulation**

### ADMINISTRATIVE COMPLAINT

This matter came before the Port St. Lucie Construction Board of Appeals on July 10<sup>th</sup>, 2025 for consideration of the complaint against Dennis Respol of Hammerhead Marine Construction LLC., pursuant to Port St. Lucie City Code section 150.520.3(h). The Board having reviewed the evidence and sworn statement of the complaint presented by City of Port St. Lucie Building Licensing Investigator, Jennifer Vannatter, deeming itself fully advised in these premises, enter the following findings of fact and conclusions of law based upon motions duly made, seconded and adopted:

The Petitioner, Jennifer Vannatter, Licensing Investigator, City of Port St Lucie was present.

The Respondent, Dennis Respol, was not present.

### FINDINGS OF FACT

1. On May 20<sup>th</sup>, 2025 the Petitioner, filed a complaint against Denis Respol, pursuant to section 150.520.2 of the Port St. Lucie City Code.
2. In the complaint, Dennis Respol is charged with violating:
  - Port St. Lucie Code Section 150. 520. 3(h): "*Knowingly or deliberately disregarding or violating any applicable building codes or laws of the state, county or the city.*"

**ADDRESSES OF VIOLATION(S):** 693 SE WHITMORE DR (MULTIPLE VIOLATIONS), 777 SE ARTON LN (MULTIPLE VIOLATIONS), 675 SE HARBOR VIEW DR

3. A copy of the complaint was sent certified and regular mail to the respondent and/or his/her attorney.
4. That on July 10<sup>th</sup>, 2025, Dennis Respol has been charged with a Formal Complaint regarding the property(ies) above, located in The City of Port St Lucie. The Charging allegations of violating Port St. Lucie Code Section 150.520.3(h) is supported by the signed and sworn complaint.
5. Pursuant to 150.520.2 (h), a determination of guilt has been made based upon the sworn complaint.

### CONCLUSION OF LAW

That by a vote of six to zero opposed, the Construction Board of Appeals, based upon the findings of fact concludes that the Respondent is guilty of the above violations.

That pursuant to Port St. Lucie City Code, section 150.520.3, a finding of guilt constitutes grounds for disciplinary action.

**BOARD ORDER**

Upon these findings, by a vote of the Board of six in favor to zero opposed, therefore it is ordered *"the suspension of permitting privileges for 365 (Three Hundred Sixty-Five) days or until the respondent brings all violations into compliance, and payment of \$205 (Two Hundred Five Dollars) in Administrative Cost is due."*


Furthermore, recommendation by a vote of the Board six in favor to zero opposed is made to the CILB for *"Letter of Reprimand"*.

The respondent is hereby notified that upon the timely filing of a Notice of Appeal with the City Clerk within fifteen (15) days of the date of the Board's decision, the decision of the Construction Board of Appeals may be appealed.

In accordance with Florida Statutes, Chapter 489.131 (7) (d) and (e), the department, the disciplined contractor, the complainant, may challenge the local jurisdiction enforcement bodies recommended penalty for board action to the Construction Industry Licensing Board. A challenge shall be filed within sixty (60) days of the issuance of the recommended penalty to the board. If challenged, there is a presumptive finding of probable cause and the case may proceed without the need for a probable cause hearing.

Failure of the department, the disciplined contractor, or the complainant to challenge the local jurisdiction's recommended penalty within the time period set forth in this subsection shall constitute a waiver of the right to a hearing before the board. A waiver of the right to a hearing before the board shall be deemed an admission of the violation, and the penalty recommended shall become a final order according to procedures developed by the board rule without further board action. The disciplined contractor may appeal this board action to the district court.

### **ADMINISTRATIVE COMPLAINT**

This matter came before the Port St. Lucie Construction Board of Appeals on July 10<sup>th</sup>, 2025 for consideration of the complaint against Dennis Respol of Hammerhead Marine Construction LLC., pursuant to Port St. Lucie City Code section 150.520.3(h). The Board having reviewed the evidence and sworn statement of the complaint presented by City of Port St. Lucie Building Licensing Investigator, Jennifer Vannatter, deeming itself fully advised in these premises, enter the following findings of fact and conclusions of law based upon motions duly made, seconded and adopted:

The Petitioner, Jennifer Vannatter, Licensing Investigator, City of Port St Lucie was present.

The Respondent, Dennis Respol, was not present.

### **FINDINGS OF FACT**

1. On May 20<sup>th</sup>, 2025 the Petitioner, filed a complaint against Denis Respol, pursuant to section 150.520.2 of the Port St. Lucie City Code.
2. In the complaint, Dennis Respol is charged with violating:
  - Port St. Lucie Code Section 150.520.3(b): "*Knowingly or deliberately disregarding or violating any applicable building codes or laws of the state, county or the city.*"

**ADDRESSES OF VIOLATION(S):** 693 SE WHITMORE DR (MULTIPLE VIOLATIONS), 777 SE ARTON LN (MULTIPLE VIOLATIONS), 675 SE HARBOR VIEW DR

3. A copy of the complaint was sent certified and regular mail to the respondent and/or his/her attorney.
4. That on July 10<sup>th</sup>, 2025, Dennis Respol has been charged with a Formal Complaint regarding the property(ies) above, located in The City of Port St Lucie. The Charging allegations of violating Port St. Lucie Code Section 150.520.3(h) is supported by the signed and sworn complaint.
5. Pursuant to 150.520.2 (h), a determination of guilt has been made based upon the sworn complaint.

### **CONCLUSION OF LAW**

That by a vote of six to zero opposed, the Construction Board of Appeals, based upon the findings of fact concludes that the Respondent is guilty of the above violations.

That pursuant to Port St. Lucie City Code, section 150.520.3, a finding of guilt constitutes grounds for disciplinary action.

**BOARD ORDER**

Upon these findings, by a vote of the Board of six in favor to zero opposed, therefore it is ordered *"the suspension of permitting privileges for 365 (Three Hundred Sixty-Five) days or until the respondent brings all violations into compliance, and payment of \$205 (Two Hundred Five Dollars) in Administrative Cost is due."*

Furthermore, recommendation by a vote of the Board six in favor to zero opposed is made to the CILB for *"Letter of Reprimand"*.

The respondent is hereby notified that upon the timely filing of a Notice of Appeal with the City Clerk within fifteen (15) days of the date of the Board's decision, the decision of the Construction Board of Appeals may be appealed.

In accordance with Florida Statutes, Chapter 489.131 (7) (d) and (e), the department, the disciplined contractor, the complainant, may challenge the local jurisdiction enforcement bodies recommended penalty for board action to the Construction Industry Licensing Board. A challenge shall be filed within sixty (60) days of the issuance of the recommended penalty to the board. If challenged, there is a presumptive finding of probable cause and the case may proceed without the need for a probable cause hearing.

Failure of the department, the disciplined contractor, or the complainant to challenge the local jurisdiction's recommended penalty within the time period set forth in this subsection shall constitute a waiver of the right to a hearing before the board. A waiver of the right to a hearing before the board shall be deemed an admission of the violation, and the penalty recommended shall become a final order according to procedures developed by the board rule without further board action. The disciplined contractor may appeal this board action to the district court.

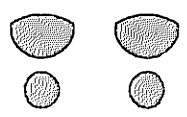
