**CONSENT TO ASSIGNMENT AND ASSUMPTION
OF AGREEMENT**

THIS CONSENT TO ASSIGNMENT AND ASSUMPTION OF AGREEMENT ("Assignment") is entered into as of the 9th day of November 2021 ("Effective Date") by and among the **CITY OF PORT ST. LUCIE**, a Florida municipal corporation, whose mailing address is 121 SW Port St. Lucie Blvd., Port St. Lucie, FL 34984 ("CITY"), **AMERICAN WATER CHEMICALS, INC.**, a foreign corporation whose address is 1802 Corporate Center Lane, Plant City, FL 33563 ("ASSIGNOR"), and **AMAYA SOLUTIONS, INC.**, a foreign corporation authorized to do business in the State of Florida whose mailing address is 1802 Corporate Center Lane, Plant City, FL 33563 ("ASSIGNEE"). CITY, ASSIGNOR and ASSIGNEE may also be referred to herein individually as a "Party" or collectively as the "Parties."

WHEREAS, the CITY and ASSIGNOR entered into Contract No. 20160120 on July 29, 2016 for the supply of Zinc-orthophosphate for the water treatment facilities for the City of Port St. Lucie as well as other tasks and Contract No. 20180167 on July 23, 2018 for the supply of anti-scalant for the water treatment facilities for the City of Port St. Lucie as well as other tasks (collectively the "Agreement"); and

WHEREAS, ASSIGNOR and ASSIGNEE entered into a Bill of Sale and Assignment and Assumption Agreement, which transfers all of ASSIGNOR's right, title and interest in and to their assets to ASSIGNEE; and

WHEREAS, ASSIGNOR desires to assign all of its rights and interest in the Agreement to ASSIGNEE and ASSIGNEE desires to assume all of ASSIGNOR's obligations under the Agreement; and

WHEREAS, the City consents to the assignment of rights,

NOW THEREFORE, in consideration of the sum of ten dollars (\$10) mutual covenants contained herein and other good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, the Parties agree as follows:

1. The above recitals are true and correct and by this reference incorporated herein and made a part hereof.
2. All other terms and conditions of the Agreement between CITY and ASSIGNOR shall remain unchanged and in full force and effect.
3. ASSIGNEE has reviewed the terms of the Agreement and ASSIGNEE hereby assumes all rights and obligations under the Agreement and agrees to be bound thereby.
4. ASSIGNEE shall be liable to CITY in any action taken for violation of any condition or covenant contained within the Agreement.

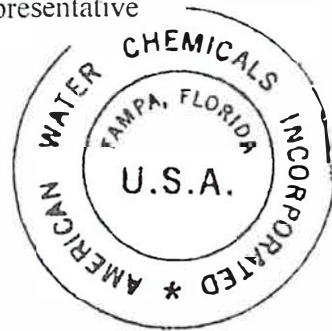
