Dear John,

This letter is to inform you of a price increase for all MWI products. This is based on the following vendor increases:

- 1. Diesel Engines costs have increased by over 20% in the last 3 years. Quotes are only valid for 60 days. Delivery times are 6-9 months
- 2. Raw materials such as steel, bearing, seals, etc. Steel products have increased by over 35% in the last 2 years. Stainless steel has increased by 45%. Bearings not only have increased in price but the delivery has increased to 5-6 months.
- 3. Hydraulic pumps and motors have increased over 35% in the last 3 years. Delivery times are 14 weeks for pumps and over 45 weeks for motors.
- 4. Labor prices- Labor costs in our industry, like the rest of the nation, have increased over 25% in the last year alone. Finding and retaining people is a struggle. MWI has increased its benefit packages to compete with other companies in similar fields.
- 5. Electric motors partials for our Submersible electric pump are now a 6-7 months delivery. Prices have increased by "only" 15-20% in the last 2 years.
- PSL is using pricing from 2008. We never increased pricing when we renewed our emergency contract.

As the economy rebounds from COVID and inflationary issues, MWI is striving to inform our customers of changes as they take place.

Hopefully we will be back to more "normal" deliveries and prices will stabilize in the near future.
