## A RESOLUTION APPROVING THE PRELIMINARY AND FINAL PLAT WITH CONSTRUCTION PLANS FOR VERANO SOUTH - POD G -PLAT NO. 5 WITHIN THE CITY OF PORT ST. LUCIE, FLORIDA ON THE REQUEST OF VERANO DEVELOPMENT, LLC (P21-208); PROVIDING FOR CONFLICT; PROVIDING FOR SEVERABILITY; AND PROVIDING AN EFFECTIVE DATE.
