## NOTICE OF PUBLIC HEARING City Council of the City of Port St. Lucie, Florida Petition to Establish the LTC Ranch West Residential Community Development District

In accordance with the provisions of Chapter 190, Florida Statutes, a public hearing will be held by the City Council of the City of Port St. Lucie beginning at 6:30 p.m., on June 14, 2021, at City Hall, 121 S.W. Port St. Lucie Blvd., Port St. Lucie, Florida 34984, to consider an ordinance granting a petition to establish a community development district which will be known as the "LTC Ranch West Residential Community Development District" (the "District"). The title of the proposed ordinance is as follows:

AN ORDINANCE OF THE CITY COUNCIL OF THE CITY OF PORT ST. LUCIE, FLORIDA ESTABLISHING THE LTC RANCH WEST RESIDENTIAL COMMUNITY DEVELOPMENT DISTRICT; PROVIDING BOUNDARIES AND FOR FUTURE EXPANSION WITH SUFFICIENTLY CONTIGUOUS LANDS; DESIGNATING INITIAL MEMBERS OF THE DISTRICT BOARD OF SUPERVISORS; PROVIDING FOWERS; PROVIDING FOR NOTICE OF SPECIAL ASSESSMENTS; PROVIDING FOR CONDITIONS; PROVIDING FOR EXCEPTIONS AND INTERLOCAL AGREEMENTS WITH THE CITY; PROVIDING FOR REPEAL OF CONFLICTING ORDINANCES; PROVIDING SEVERABILITY; PROVIDING FOR FILING WITH THE DEPARTMENT OF STATE; PROVIDING AN EFFECTIVE DATE.

The proposed community development district is comprised of approximately 777.267 acres, more or less, generally located south of Midway Road, north and west of Glades Cut Off Road and east of I-95. The Petitioner has proposed to establish the LTC Ranch West Residential Community Development District to plan, finance, acquire, construct, operate and maintain infrastructure and community facilities, which may be authorized by such districts under Florida law including but not limited to Chapter 190, Florida Statutes.

Copies of the petition, department reports and proposed ordinance are open to public inspection at the office of the City Clerk, City of Port St. Lucie, City Hall, Room 358, 121 S.W. Port St. Lucie Blvd., Port St. Lucie, Florida 34984.

All interested persons and affected units of general - purpose government shall be given an opportunity to appear at the hearing and present oral or written comments on the petition. Any persons or affected unit of general - purpose local government, who wish to appeal any decision made by the Board with respect to any matter considered at this public hearing will need a record of the proceedings. For that purpose the person or unit of general - purpose local government may need to insure that a verbatim record of the proceedings is made that includes the testimony and evidence upon which the appeal is to be based.
