SPECIAL WARRANTY DEED

THIS SPECIAL WARRANTY DEED is made and entered into as of September 26th 2025, by and between TAV PORT ST LUCIE, LLC, a Delaware limited liability company ("Grantor"), whose address is c/o Twenty Lake Holdings, LLC, 500 Frank W Burr Blvd., Suite 720, Teaneck, NJ 07666, and PEBB PSL, LLC, a Florida limited liability company, and BANYAN PSL LLC, a Florida limited liability company, (collectively, the "Grantee"), whose address is 7900 Glades Road, Suite 600, Boca Raton, Florida 33434.

WITNESS, that Grantor, in consideration of the sum of Ten Dollars and other valuable consideration paid by Grantee, the receipt of which is hereby acknowledged, does by these presents, BARGAIN and SELL, CONVEY and CONFIRM unto Grantee, its successors and assigns, that certain real property legally described on the attached Exhibit A (the "Property"), SUBJECT TO all matters which are set forth on Exhibit B attached hereto (the "Permitted Encumbrances"), without intent to reimpose same.

TO HAVE AND TO HOLD, the same in fee simple forever, together with all rights and appurtenances to the same belonging unto the said Grantee.

Grantor hereby covenants with Grantee, and binds itself, its successors and assigns, to warrant and forever defend all and singular the title to the Property unto Grantee, its successors and assigns, against any person whomsoever lawfully claiming or to claim the same or any part thereof by, through or under Grantor, but not otherwise, and that the Property is free of all encumbrances, except taxes accruing subsequent to December 31, 2024, and except for the Permitted Encumbrances.
