NOW THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the parties do hereby agree as follows:

Amendment #5 - Additional Scope of Work not included in the original Contract:

1. CO #10 – Extension of the Riverwalk Boardwalk under Port St. Lucie Blvd. to connect the existing north and south sections. Construct steel spans and timber spans per drawings and specifications. Install boardwalk lighting and water service per plan. The Boardwalk connection was delayed until FDOT completed their repairs under the bridge. FDOT recently notified the City that their work has been paused and now they will permit the boardwalk connection construction without further delays. Total cost is \$1,373,636.38. No additional days are required.
