Payment Terms and Financing Options

Our payment terms will be net 30 for Sourcewell Members purchasing through this RFP contract. Our complete standard terms and conditions are included with our pricing examples in Section 4 of this RFP.

2) Do you provide leasing or financing options, especially those options that schools and governmental entities may need to use in order to make certain acquisitions?

We do not offer leasing or financing options.

3) Briefly describe your proposed order process. Please include enough detail to support your ability to report quarterly sales to Sourcewell. The Nucor Buildings Group Commercial Services (NBGCS) Team will provide a single point of contact for all Sourcewell Members for both pre-sale and post-sale. NBGCS will work directly with each Sourcewell Member to coordinate the scope and the delivery of products needed for the building solution on estimates and purchase orders. One of our NBGCS Project Coordinators will continue to be the single point of contact for any questions that may arise through the construction process.

Each order will be received and logged at the NBGCS office allowing consistent tracking for reporting quarterly sales and shipments to Sourcewell. Each order will be reviewed by our Customer Service Supervisor or Manager of Commercial Services to ensure it meets the expectation of pricing levels and scope defined within this RFP contract with Sourcewell.

Our National Accounts and District Sales Managers (field sales force) will coordinate with Sourcewell Members to align them with local Authorized Builders. These local professionals will work with Sourcewell Members to ensure local building code and construction requirements are met. Sourcewell Members will contract directly with these local Authorized Builders for any services outside the material supply of the building solution.

4) Do you accept the P-card procurement and payment process? If so, is there any additional cost to Sourcewell Members for using this process?

We do not offer the P-card procurement and payment process at this time.

Warranty

The Nucor Buildings Group offers a one year materials and workmanship warranty with for our products. Additional warranties are available for the roof systems and paint finishes. Sample copies of our warranties from included as Appendix 4 to this RFP for reference.

- Do your warranties impose usage restrictions or other limitations that adversely affect coverage?

All warranties are subject to industry standard exclusions indicated in our warranty documents. Please reference warranty guide included with this RFP submittal.

- Do your warranties cover the expense of technicians' travel time and mileage to perform warranty repairs?

We do not perform warranty repairs but we do work with our customers to investigate and resolve any potential issues that arise. The investigation could require site visits for inspections at times which is included within or warranty process.

- Are there any geographic regions of the United States for which you cannot provide a certified technician to perform warranty repairs? How will Sourcewell Members in these regions be provided service for warranty repair?

Any repairs required would be coordinated with local Authorized Builders with costs coordinated with us.

- Will you cover warranty service for items made by other manufacturers that are part of your proposal, or are these warranties issues typically passed on to the original equipment manufacturer?

The Nucor Buildings Group will process the warranty claims for all materials we supply.

- What are your proposed exchange and return programs and policies?

Our products are custom engineered for each project so we do not accept exchanges or returns.

- 6) Describe any service contract options for the items included in your proposal.

The Nucor Buildings Group offers extensive training opportunities to our Authorized Builder network. We provide technical support through Field Technicians and engineering resources to our Authorized Builders. Sourcewell Members can contract directly with these local professionals for any continued maintenance needs for a specific project.

Pricing, Delivery, Audits, and Administrative Fee

- 7) Provide a general narrative description of the equipment/products and related services you are offering in your proposal.

The Nucor Buildings Group of brands offers custom engineered metal building systems and solutions packages. This includes product design, detailing, fabrication, and delivery of metal building systems. For a detailed explanation of our products, please visit our websites at www.nucorbuildingsgroup.com which includes links to each of our brands.

We will provide metal joist and decking systems typically used for roof or floor support systems from our Nucor owned Vulcraft/Verco Group. We will also provide non-Nucor produced products including walk doors/windows, roof curbs, skylights, foam insulated panel systems, building insulation systems, and miscellaneous items from our list of approved vendors. All of these items will be priced and included in our purchase agreement on a project specific basis.

The Nucor Buildings Group has over 100 sales professionals in the field working with a network of over 2,600 Authorized Builders across the US and Canada. We will work with Sourcewell Members to align them with the best local contractors who will provide the highest level of services including site preparation, installation/erection of the metal building package, and any ancillary services specifically needed for a project. These services will then be procured/contracted directly with these local Builders.

- 8) Describe your pricing model (e.g., line-item discounts or product-category discounts). The Nucor Buildings Group of brands maintain a computerized pricing program (eQuote) used by our Authorized Builders in the field to price our building solutions with current market pricing. The pricing is updated regularly to maintain competitive pricing levels with the most current level of material costs and market conditions. As such, the pricing provided by our eQuote software is current pricing requiring no special discounts for current market conditions. Example purchase agreements from our eQuote pricing software are included as Section 4 of this RFP.

- 9) Please quantify the discount range presented in this response. For example, indicate that the pricing in your response represents is a 50% percent discount from the MSRP or your published list.

We do not offer a list price or MSRP type pricing system in order to provide a standard discount. Our products are custom engineered building packages not having a SKU for items. The pricing provided by our eQuote system is current pricing requiring no special discounts for current market conditions. The value for Sourcewell Members is in purchasing our materials directly from the Nucor Buildings Group of brands at the same competitive pricing level offered to our Authorized Builders.

- 10) The pricing offered in this proposal is

This RFP with Sourcewell will be the Nucor Buildings Group's first approach to direct servicing the municipal, educational, and non-profit marketplace. We are offering to provide materials to Sourcewell Members at the same pricing levels standardly offered to our Authorized Builders for individual bidding processes.

- 11) Describe any quantity or volume discounts or rebate programs that you offer.

The philosophy of the Nucor Buildings Group is to maintain consistently competitive pricing in the field to be used on each and every project which is reflected in our eQuote pricing system. This approach has proved success for our brands as we have grown by earning the business of each of our Authorized Builders. As such, we do not offer our Authorized Builder customers quantity discounts, volume discounts, or rebate programs which would effect the overall cost of our products. We are committed to maintaining competitive pricing for all projects regardless of the size or quantity of materials. We are confident our direct pricing of product to Sourcewell Members will prove to be a value to each member.

The Nucor Buildings Group will include these items in our purchase order agreement on a cost plus percentage basis. The percentage varies based upon the level of business risk and internal costs to deliver associated with the type of material supplied.

This cost includes all additional charges that are not directly identified as freight or shipping charges. The Nucor Buildings Group of brands will include freight and all other costs associated with our building system solution within our estimate for each project. Taxes are not included on estimates but will be clearly noted as not being included. Unless required tax documentation is provided, the taxes for the US will be included on final invoices.

- 14) If travel expense, delivery or shipping is an additional cost to the Sourcewell Member, describe in detail the complete travel expense, shipping and delivery program.

The Nucor Buildings Group of brands will include freight with our estimate of project.

The Nucor Buildings Group purchase agreement will include freight for all overseas shipments to the US continental Port of Call. Sourcewell Members will need to coordinate and contract overseas shipment from the US continental Port of Call to their specific jobsite.

One of our NBGCS Project Coordinators will continue to be the single point of contact for any questions that may arise through the construction process.

Each order will be received and logged at the NBGCS office allowing consistent tracking for reporting quarterly sales and shipments to Sourcewell. Each order will be reviewed by our Customer Service Supervisor or Manager of Commercial Services to ensure it meets the expectation of pricing levels and scope defined within this RFP contract with Sourcewell. All documentation will be maintained at the NBGCS office to ensure ease of self-auditing.

The Nucor Buildings Group proposes a 2% administrative fee to be paid to Sourcewell for facilitating, managing, and promoting the Sourcewell Contract. Upon award of the contract, we will coordinate the timing and processes of payments as well as the reporting and auditing processes with Sourcewell.


