WHEREAS, the Contract is in effect through the Current Contract Term as defined above; and

NOW THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the parties do hereby agree as follows:

1. Market conditions continue to be extremely volatile, and several resin suppliers have declared force majeure. The extreme weather impact on infrastructure, demand outpacing supply, strong export demand and rail transportation delays has put continued upward pressure on resin pricing and availability. Inflationary and transportation cost are also playing a significant factor in the cost to supply materials.
