AN ORDINANCE OF THE CITY OF PORT ST. LUCIE, FLORIDA, AMENDING THE COMPREHENSIVE PLAN OF THE CITY OF PORT ST. LUCIE TO INCLUDE A LARGE-SCALE AMENDMENT TO THE FUTURE LAND USE MAP TO CHANGE THE FUTURE LAND USE DESIGNATION FOR APPROXIMATELY 150 ACRES FROM UTILITY (U) TO LIGHT INDUSTRIAL (LI) FOR A PARCEL OF LAND LEGALLY DESCRIBED IN ATTACHED EXHIBIT "A" AND GENERALLY LOCATED SOUTH OF MIDWAY ROAD, NORTHWEST OF GLADES CUT-OFF ROAD, AND IMMEDIATELY WEST OF MCCARTY ROAD; PROVIDING FOR CONFLICT; PROVIDING FOR SEVERABILITY; AND PROVIDING AN EFFECTIVE DATE. (P24-057)

WHEREAS, the City of Port St. Lucie, Florida, has adopted a comprehensive plan known as the City of Port St. Lucie Comprehensive Plan adopted by Ordinance 97-50, as subsequently amended via Ordinance 12-19 and Ordinance 20-28; and

WHEREAS, the City is committed to planning and managing the growth of the City; and

WHEREAS, the City has the authority to amend its Comprehensive Plan pursuant to Chapter 163, Part II, Florida Statutes; and

WHEREAS, the City Council of the City of Port St. Lucie desires to amend the Future Land Use Map portion of the Comprehensive Plan to guide and control the future development of the City and to preserve, promote, and protect the public's health, safety and welfare; and

WHEREAS, the City of Port St. Lucie has initiated a large-scale amendment (P24-057) for City of PSL Glades Wastewater Treatment Plan (WWTP) Adjacent Lands for property legally described in attached Exhibit "A" and generally located south of Midway Road, Northwest of Glades Cut-Off Road, and immediately West of McCarty Road to amend the Future Land Use Map of the City of Port St. Lucie Comprehensive Plan in accordance with Section 163.3187, Florida Statutes, to change approximately 150.37 acres from the future land use designation of Utility (U) to Light Industrial (LI) future land use designation;

and

WHEREAS, the changes to the future land use map are shown with more particularity in the attached Exhibit "B"; and

WHEREAS, the City of Port St. Lucie Planning and Zoning Board has been duly designated as the local planning agency pursuant to Section 163.3174 et. seq., Florida Statutes; and

WHEREAS, the Planning and Zoning Board met on July 2, 2024, at a duly noticed public meeting, and, pursuant to the procedures of Chapter 163, Florida Statutes, Part II, reviewed and heard testimony concerning the proposed amendment (P24-057) to the City's Comprehensive Plan, and submitted its recommendations thereon to the City Council; and

WHEREAS, the City Council held the first reading (Transmittal Hearing) of the Ordinance at a public hearing on July 8, 2024; and

WHEREAS, the City Council held the second reading (Adoption Hearing) of the Ordinance at a public hearing on October 14, 2024; and

WHEREAS, the amendment was submitted to and reviewed by the state land planning agency on August 8, 2024; and

WHEREAS, the said public hearings were held with all required public notice for the purposes of hearing and considering the recommendations and comments of the general public, the Local Planning Agency, other public agencies and other jurisdictions prior to final action on the Comprehensive Plan Amendment set forth herein; and

WHEREAS, the City Council has considered to amend the City's Comprehensive Plan and has determined to amend the Future Land Use Map of the City's Comprehensive Plan as provided herein; and

WHEREAS, all conditions required for adoption of this large-scale Comprehensive Plan Amendment have been met, including the necessary hearings and public notices.

NOW, THEREFORE, THE CITY OF PORT ST. LUCIE HEREBY ORDAINS:

<u>Section 1</u>. Ratification of Recitals. The City Council of the City of Port St. Lucie, Florida, hereby adopts and ratifies those matters as set forth in the foregoing recitals.

Section 2. The Comprehensive Plan of the City of Port St. Lucie for the property legally described in attached Exhibit "A" is hereby amended to change the Future Land Use Map of the City of Port St. Lucie Comprehensive Plan for approximately 150 acres from Utility (U) to Light Industrial (LI). The changes to the future land use map are shown with more particularity in the attached Exhibit "B".

Section 3. Future Land Use Map Adopted. The Future Land Use Map of the City of Port St. Lucie is hereby amended and shall be conformed to be consistent with Exhibit "B" to this Ordinance as set forth by this Comprehensive Plan Amendment.

<u>Section 4.</u> Conflict. If any ordinances, or parts of ordinances, or if any sections, or parts of sections, of the ordinances of the City of Port St. Lucie, Florida, are in conflict herewith, this Ordinance shall control to the extent of the conflicting provisions.

<u>Section 5.</u> Severability. The provisions of this ordinance are intended to be severable. If any provision of this Ordinance is determined to be void or is declared illegal, invalid, or unconstitutional by a court of competent jurisdiction, the remainder of this Ordinance shall remain in full force and effect.

<u>Section 6</u>. Effective Date. The effective date of this plan amendment shall be as provided by law.
