## RENEWAL AGREEMENT AND SECOND AMENDMENT TO MARCH 28,2022 INTERLOCAL AGREEMENT BY AND BETWEEN ST. LUCIE COUNTY, FLORIDA, AND THE CITY OF PORT SAINT LUCIE

THIS RENEWAL AGREEMENT AND SECOND AMENDMENT is made this day of July , 2025, by and between ST. LUCIE COUNTY, a political subdivision of the State of Florida ("County"), and CITY OF PORT ST. LUCIE ("City").

WHEREAS, the parties entered into an Interlocal Agreement on March 28, 2022, to provide for a cost share agreement relating to improvements for a stormwater treatment area (STA) for Hog Pen Slough ("Interlocal Agreement"); and

WHEREAS, the Interlocal Agreement expired on March 28, 2024; and

WHEREAS, the parties renewed the Interlocal Agreement and amended the Interlocal Agreement to extend the term to June 30, 2025, on July 2, 2024; and

WHEREAS, the parties desire to renew the Interlocal Agreement and to amend the Interlocal Agreement to further extend the term as set forth herein.

**NOW, THEREFORE**, the parties hereto, in consideration of the mutual covenants, agreements, terms, and condition contained herein, do agree as follows:

- 1. Pursuant to Section 12 of the Interlocal Agreement the parties agree to extend the term of the Interlocal Agreement.
- 2. Section 11, Recording; Effective Date, is hereby amended to read:
- 11. **Recording; Effective Date**. This Agreement shall be recorded by the County in the Official Public Records of the Clerk of the Court of St. Lucie County. Florida in accordance with Section 163.01(11), Fla. Stat. A copy of the recorded Agreement shall be forwarded to the City. The Effective Date of this Agreement shall be the date the Agreement is initially recorded in the public records of St. Lucie County, Florida and shall remain in effect until December 31, 2025, thereafter ("initial term"), unless it is extended as set forth in Section 12 below or terminated as set forth in Section 13 below.
- 3. Section 12, Extension, is hereby amended to read:
- 12. **Extension**. Upon expiration of the initial term, this Agreement may be extended upon written consent of both parties.
- 4. Except as amended herein, the remaining terms and conditions of the Interlocal Agreement shall remain in full force and effect.
