SUBJECT: P24-114 Southern Grove 7B Preliminary & Final Plat

Traffic Generation & Circulation Approval

This application and Traffic Report prepared by Kimley-Horn & Associates, Inc. dated March 7, 2025 has been reviewed by the Public Works Department and our 3rd party traffic consultant WSP, Inc. and found to be in compliance with the adopted level of service and requirements of Chapter 156 of City Code and Public Works Policy 19-01pwd.

The current Traffic Analysis provided for the Southern Grove 7B Preliminary & Final Plat (P24-114) (the "Plat") includes the anticipated trips per the ITE Trip Generation Manual, 11th edition based on assumptions of land use. The assumptions include a 6,500 SF gas station with 16 fueling pumps, 2,500 SF coffee shop with drive thru, 5,000 SF restaurant with drive-thru, 15,000 SF General Commercial Use, 35,325 SF of Automobile Sales Dealership, and 459 multi-family mid-rise dwelling units. This amounts to over 1,100 PM Peak Hour trips divided over 3 driveways with varying levels of accessibility.

Based upon review of the Traffic Analysis, the following traffic signals are warranted: (A) traffic signal at the intersection of Becker Road and Tract R1 (Limpkin Lane); and (B) the traffic signal at Becker Road and SW Anthony F. Sansone Sr. Blvd.

Public Works recommends approval of the Plat, subject to the following conditions:

- 1. The traffic signal at the intersection of Becker Road and Tract R1¹ and traffic signal at Becker Road and SW Anthony F. Sansone Sr. Blvd. must be constructed and completed as follows:
 - a. Construction shall commence within 12 months of the Plat's approval by City Council; and

- b. Certification of the traffic signal shall be completed within 18 months of the Plat's approval by City Council.
- 2. Within 30 days after the Public Works Pre-Construction meeting for the Plat, a temporary median within the existing full access intersection of Becker Road and Tract R1 must be installed to restrict the access to right in/right out from their site with a left in until the traffic signal at this intersection is installed and operational.
- 3. The intersection of SW Anthony F. Sansone Sr. Blvd and Becker Road will remain restricted to right-in and right-out access only from the south until the traffic signal at this intersection is installed and operational.²
- 4. Upon submittal of the construction plans for either signal to the City of Port St. Lucie, monthly updates shall be submitted to the Public Works Department on the progress and status of the signal design, permitting and construction progress by the responsible party of each traffic signal.
- 5. The City may withhold Public Works engineering permits within the Plat if the obligations set forth in Conditions 1 through 4 are not met within the timeframes stated above. Only the traffic signal located at Becker Road and Tract R1 is subject to Force Majeure Events or Weather Days, as defined in the Agreement, if applicable. This condition is intended to supplement and is not intended to supersede rights or remedies the City may have with regard to the Agreement and the City reserves all of its rights and remedies.
