LWCF

- Administered by FDEP, the LWCF grant program provides financial assistance for the acquisition or development of public outdoor recreation areas and facilities for the enjoyment and benefit of the general public.
- Typical LWCF projects include trails, athletic fields, picnic areas, restrooms, and other outdoor recreation facilities.
- Grant application: \$785,000 (50% local match required)
 - Proposed Project: Restroom improvements, new playground equipment, picnic pavilion, soccer field upgrades, fitness station, dog park enhancements, and a new maintenance facility.

McChesney Park

- \$785,000 in FY 26/27 CIP McChesney Park Improvements
- The City plans to replace the inclusive playground at McChesney Park, which has reached the end of its service life, using funds already programmed in the FY 2026–27 CIP. While the current CIP funding focuses on the playground, additional grant support could expand the project to include a new maintenance building, restroom upgrades, and improvements to the dog park and soccer fields, as well as a new fitness station and picnic pavilion.
