**Title**

Approval of the Bid for Park and Playground Equipment, SDMC No. 26-0041-MR, Estimated in the Amount of \$1,300,000.00 Annually (Multiple Funding Sources)

**Executive Summary**

Park and playground equipment are requested by schools and departments periodically throughout the school year to replace/repair broken equipment and to add/replace identified old/obsolete play structures. Each vendor listed agrees to adhere to all required codes and standards and provide the School District of Manatee County with a fixed percentage discount on various manufacturers plus installation where applicable. Based on these criteria and to offer the schools a variety of manufacturer's equipment, it is recommended to award to all responsive bidders.

The requested contract is for the period of September 1, 2025 through August 31, 2030. This bid is for a period of five (5) years with the option to renew for two (2) additional one-year periods.

Fiscal Year 2022-2023: \$1,889,647.54
