Purpose

The purpose of the appraisal is to develop an opinion of market value of the subject property as defined in this report (see limiting conditions attached for definition).

Intended Use

This report was prepared for our client, City of Port St. Lucie. The intended use of this appraisal is to assist the client mentioned in this report in evaluation of the Subject Property for land valuation of 1454 SE Larkwood Circle, Port Saint Lucie, FL, 34952. The scope of work performed is specific to the needs of the intended user and the intended use. No other use is intended and the scope of work may not be appropriate for other use.

Scope of Work

Subject Property Identification:

Danielle M Crowe has viewed readily accessible areas of the lot, and has viewed the property solely for valuation purposes and to observe property characteristics that a typical purchaser would consider in their decision making process, as well as those items outlined in the assumptions and limited conditions and certification to this appraisal. Personal property was not included in the appraised value.

Sources of Information:

The appraisal is based on the information gathered from public records; viewing of the Subject Property, neighborhood and comparable properties; and other sources specifically identified in this report. Subject Property is located in SE Port St Lucie, and is located in a pocket neighborhood that is east of SE Federal Highway, The Subject's neighborhood is a predominately residential neighborhood consisting of detached and attached single-family dwellings, some commercial property and a public park.

The Subject is zoned RM-8 which is Multiple-Family Residential Zoning District.

The Subject Property is located in the community, Rivergreen Villas which is an established community of attached villas. Per a search of St Lucie County tax records and FLEXMLS, the villas were mostly constructed in 1979, with no newer development noted. We noted the adjacent site is currently under contract. Per analysis of the listing for the adjoining site, the Subject was mentioned in the FLEXMLS description as the Subject's site and 1450 SE Larkwood Circle would have to be joined as the only reasonable, legal, physical and feasible use of the site is for the development of a duplex.

Sales Comparison Analysis

The Subject's site is located in an established community with attached single-family units. The site is approximately 5,484 square feet and is irregular in shape and its width is approximately 37 feet +/- . Due to the property's physical characteristics, zoning, site size and probable Highest and Best Use, we were unable to provide a viable closed comparable that had similar circumstances. We did find a listing/contract with the same situation. Based on a search of vacant site sales in the Subject's market area, we were able to provide a larger vacant site in close proximity, two smaller sites in the same market area in a Planned Unit Development, and a contract on the Subject's adjacent site. We determined that the best indicator of value was based on price per square foot.

Comparable 1 is a 10,000 square foot site with residential views and paved road access. The site sold on 01/2024 for \$95,000 or \$9.50 per square foot.

Comparable 2 is located in a Planned Unit Development and was considered as it is most similar in site size. The site sold on 02/2024 for \$45,000 or \$8.09 per square foot.

Comparable 3 is located in a Planned Unit Development and was considered as it is among the smallest, recently closed vacant sites. The site has views of a preserve and sold on 05/2024 for \$65,000 or \$10.06 per square foot.

Contract 4 is located adjacent to the Subject Property and went under contract as of 02/2024. The ask price was \$74,400 or \$12.11 per square foot. We considered an adjustment for list/sale ratio. The site is superior in size and per data provided by MLS description, is best suited to adjoin the Subject Property for future development of an attached unit dwelling.

The comparable sales indicate an adjusted range from \$45,000 to \$95,000, or \$8.09 to \$10.90 per square foot and are considered to be the best indicators of market value. In our value conclusion we considered the Subject's site size, views and most probable future Highest and Best Use as combined with the adjoining site (Contract 4). Therefore, we concluded the Subject Property's value to be \$55,000 or \$10.00 per square foot as it is well supported by the adjusted and unadjusted sales prices of the comparable sales.

*Adjustments to the comparables must be made for special or creative financing or sales concessions. No adjustments are necessary for those costs which are normally paid by sellers as a result of tradition or law in a market area; these costs are readily identifiable since the seller pays these costs in virtually all sales transactions. 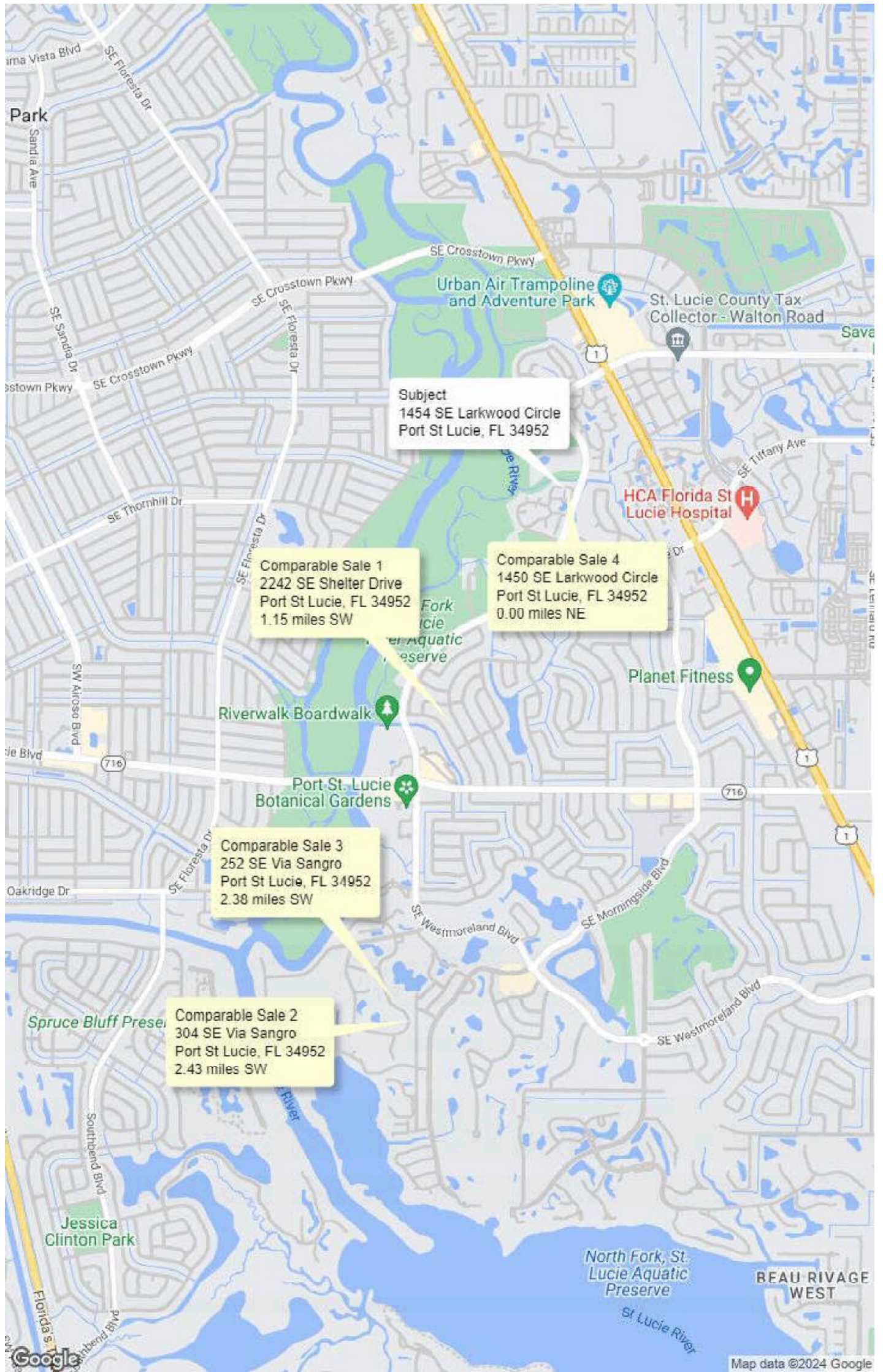

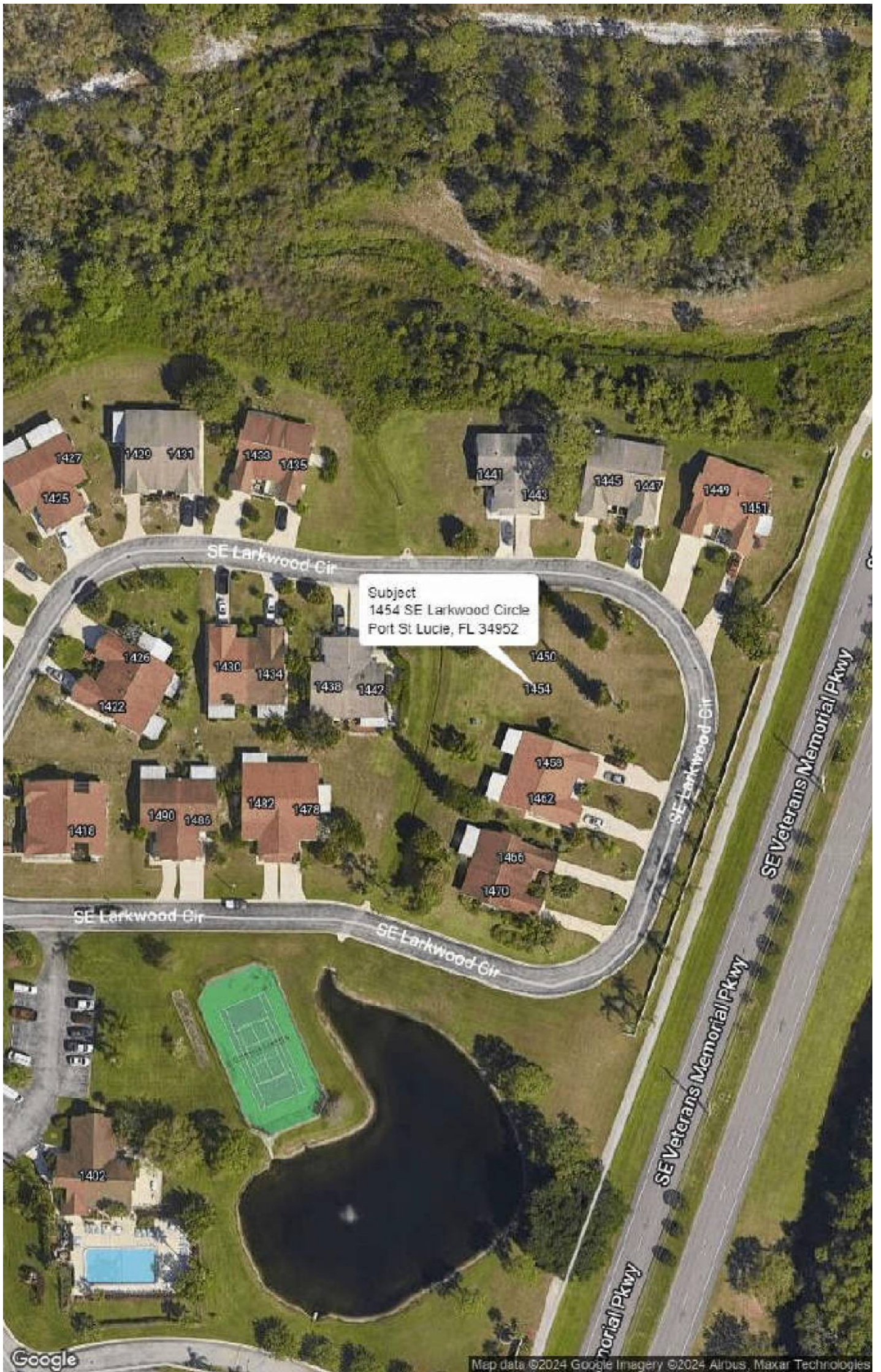
