A RESOLUTION APPROVING THE FINAL PLAT WITH CONSTRUCTION PLANS FOR VERANO SOUTH - POD G - PLAT NO. 4 WITHIN THE CITY OF PORT ST. LUCIE, FLORIDA ON THE REQUEST OF ASTER CREEK DEVELOPMENT, LLC (P22-213); PROVIDING FOR CONFLICT; PROVIDING FOR SEVERABILITY; AND PROVIDING AN EFFECTIVE DATE.

WHEREAS, the City of Port St. Lucie, Florida has been requested by Daniel Sorrow, acting as agent for Aster Creek Development LLC to approve the final plat with construction plans for Verano South - POD G - Plat No. 4, within the City of Port St. Lucie, Florida; and

Rager, P.S.M., as designated on the attached said Plat.

<u>Section 3</u>. That the Mayor and City Clerk of the City of Port St. Lucie, Florida, are hereby authorized to countersign the said plat so it may be properly recorded in the public records of St. Lucie County, Florida.

<u>Section 4.</u> Conflicts. If any Resolution, or parts of any Resolution, are in conflict herewith, this Resolution shall control to the extent of the conflicting provisions.

<u>Section 5</u>. <u>Severability</u>. The provisions of this Resolution are intended to be severable. If any part of this Resolution is determined to be void or is declared illegal, invalid, or
