TERMINATION OF DECLARATION OF RESTRICTIVE COVENANTS

WHEREAS, on June 13, 1998, a Declaration Restrictive Covenants was executed by Mike Skipper and Deborah Sue Skipper (the "Previous Owners") and subsequently recorded on June 15, 1998, in Official Records Book 1152, Page 1051, of the Public Records of St. Lucie County, Florida, encumbering the following described property, to wit:

WHEREAS, by virtue of that certain General Warranty Deed recorded on April 30, 2020, in Official Records Book 4415, Page 42, of the Public Records of St. Lucie County, Florida, Romanoff Dominique is the current owner of the Subject Property and wishes to separate Lots 2 and 21, and no longer desires to occupy the Subject Property as one single residential unit; and

WHEREAS, the City of Port St. Lucie agrees to the Termination of said Declaration of Restrictive Covenants, upon payment of the total sum of Two Hundred Dollars and Zero Cents (\$200.00), which sum represents the administrative fee for processing the request to terminate the Declaration of Restrictive Covenants, there being no outstanding assessments due and owing on the Subject Property based upon equivalent residential connections (ERC) within the Utility Service assessment area.

NOW, THEREFORE, for and in consideration of the sum of \$200.00, and other good and valuable consideration the receipt and sufficiency of which are hereby acknowledged, the City of Port St. Lucie hereby covenants and agrees as follows:

- 1. The foregoing recitals are true and correct and are incorporated herein by reference.
- 2. The City of Port St. Lucie hereby acknowledges receipt of full and complete payment in satisfaction of the referenced Declaration of Restrictive Covenants and said Declaration of Restrictive Covenants is hereby released, satisfied, and discharged in its entirety.
- 3. The Declaration of Restrictive Covenants recorded on June 15, 1998, in Official Records Book 1152, Page 1051, of the Public Records of St. Lucie County, Florida, restricting the Subject Property to one single residential unit is hereby terminated.
- 4. By the Termination of said Declaration of Restrictive Covenants, the lots described herein may each be subject to assessments by the City of Port St. Lucie as a separate residential unit.
- 5. Lots 2 and 21, Block 2969, Port St. Lucie Section Forty-Three, may be developed independently of each other in accordance with the rules and regulations of the City of Port St. Lucie.
