# **ORDINANCE 16-44**

AN ORDINANCE AUTHORIZING THE CITY MANAGER OF THE CITY OF PORT ST. LUCIE TO ENTER INTO A FIRST AMENDMENT TO THE LEASE AGREEMENT BETWEEN THE CITY OF PORT ST. LUCIE AND THE SCHOOL BOARD OF ST. LUCIE COUNTY, FLORIDA; PROVIDING AN EFFECTIVE DATE.

# THE CITY OF PORT ST. LUCIE HEREBY ORDAINS:

Section 1. The City Manager of the City of Port St. Lucie is hereby authorized and directed to enter into a First Amendment to Lease Agreement between the City of Port St. Lucie and the School Board of St. Lucie County, Florida, for said leased premises located at the former site of Port St. Lucie Elementary School, more particularly described in the First Amendment to the Lease Agreement attached hereto as Exhibit "A" and incorporated by reference herein.

Section 2. This Ordinance shall become effective ten (10) days after its final adoption.

### FIRST AMENDMENT TO LEASE AGREEMENT

WHEREAS, on or about November 29, 2011, the City of Port St. Lucie ("City") and the School Board of St. Lucie County ("Board") entered into a Lease Agreement for property located at athletic fields at the site of the former Port St. Lucie Elementary School, particularly described in the Exhibits attached to the Lease Agreement; and

WHEREAS, the City and the Board wish to amend the Lease Agreement to modify the term of the lease; and

**NOW THEREFORE**, in consideration of the mutual covenants and agreements hereinafter set forth and other good and valuable considerations, the receipt and sufficiency of which are hereby acknowledged, the parties hereby agree as follows:

- The foregoing recitals are true and correct and are incorporated herein by reference. All
  defined terms as used herein shall have the same meaning and effect as the Lease Agreement.
- Section 2 of the Lease Agreement is hereby deleted in its entirety and replaced with the following:
  - 2. <u>Term.</u> This Lease shall be for a period commencing as of the Effective Date and terminating on midnight of the 15th day of June, 2021.
- This First Amendment shall become effective when signed by all the parties and approved by the City Council of the City of Port St. Lucie.
- 4. Except as modified by this First Amendment, the Lease Agreement remains unmodified and in full force and effect and the parties hereby ratify, confirm, and adopt the Lease Agreement, as amended, in accordance with the terms thereof.
