The Victims' Assistance Unit (VAU), operating within the Criminal Investigations Division (CID) of the Port St. Lucie Police Department, is the city's sole provider of crisis response services for crime victims. VAU works in close coordination with detectives and patrol officers to ensure immediate, compassionate support for victims of violent crimes, including Homicide, Traffic Homicide, Armed Robbery, and other serious offenses.

VAU advocates are available daily to assist victims who seek help in person, ensuring that every crime victim within PSL has access to essential support services.

Continued VOCA funding is essential to sustain vital services, ensuring victims receive immediate, professional assistance, advocates provide emotional support, resources, and guidance, and walk-in services remain accessible to all residents. Without this funding, the ability to offer consistent, high-quality support to crime victims would be greatly reduced.\*
