If within nine (9) months after the date of which this Quit Claim Deed is recorded in the Public Records of St. Lucie County, Florida, the following events have not occurred, then Grantor, or its successors and assigns, by recording a notice of such reversion in the Public Records of St. Lucie County, Florida, provided that such notice is recorded no later than ninety (90) days after the end of the foregoing nine

(9) month period, whereupon fee simple title to the Property shall be deemed to have reverted to the Grantor:

- a. The Southern Grove School Site Agreement is amended, and recorded in the Public Records of St. Lucie County, Florida, to include the Property as School Site (as defined in the Southern Grove School Site Agreement); and
- b. The Southern Grove School Site Agreement is amended to remove any other property currently described as a School Site and owned by the City of Port St. Lucie or the Port St. Lucie Governmental Finance Corporation; and
- c. Fee simple title to the Property is transferred to the School Board of St. Lucie County, Florida.
