1. Five proposals were received in response to this solicitation. The respondents were:
 - 1.1 ACRO SERVICE CORPORATION
 - 1.2 AMTEC HUMAN CAPITAL
 - 1.3 KNOWLEDGE SERVICES
 - 1.4 US TECH SOLUTIONS
 - 1.5 22ND CENTURY TECHNOLOGIES, INC.
2. The purpose of this contract is to provide Staffing Services and Related services and Solutions. Maricopa County served as the lead agency on this procurement in Behalf of US Communities. This is a nationwide contract that all members of US Communities may use.
3. Five proposals were received for this solicitation. Amtec Human Capital was determined to be non-responsive and rejected.
4. The proposals were evaluated by a team of County Employees and representatives from other agencies. The scores are as follows:

4.1 ACRO SERVICE CORPORATION	93.5
4.2 KNOWLEDGE SERVICES	91.4
4.3 US TECH SOLUTIONS	75.8
4.4 22 ND CENTURY TECHNOLOGIES, INC.	72.1
5. Based on the Evaluation Committee's scoring of the responsive proposals, a determination has been made to short-list the Respondents for this solicitation to the two highest scoring proposals (scoring over 90) which are ACRO SERVICE CORPORATION and KNOWLEDGE SERVICES. Clarifications questions shall be issued and interviews will be held with the two (2) highest rated acceptable proposers and Best and Final Offers will be requested. US TECH SOLUTIONS and 22ND CENTURY TECHNOLOGIES, INC. was notified that they are no longer being considered.

6. After interviews and Best and Final Offers from these Two (2) acceptable proposers the final scores are as follows:
