

RESOLUTION 25-R__

A RESOLUTION OF THE CITY OF PORT ST. LUCIE, FLORIDA, AUTHORIZING THE FINAL ACCEPTANCE OF PUBLIC ROADWAY IMPROVEMENTS FOR A PORTION OF SW HEGENER DRIVE (P23-167), CONSTRUCTED BY SANSONE GROUP PROVIDING FOR CONFLICTS; PROVIDING FOR SEVERABILITY; AND PROVIDING AN EFFECTIVE DATE.

WHEREAS, Sansone Group, a Florida limited liability company (hereinafter, “Developer”), an affiliated entity of the Developer for the Southern Grove Legacy Park North MPUD, has completed the construction of certain public roadway improvements, specifically SW Hegener Drive, the plat and construction plans (P23-167) for which have been previously approved on December 4, 2023, by the City Council of the City of Port St. Lucie via Resolution 23-R129; and

WHEREAS, the plat of Southern Grove Plat No. 45 was recorded on December 26, 2023, in Plat Book 121, at Pages 3 - 6, of the Public Records of St. Lucie County, Florida; and

WHEREAS, the public improvements constructed by Sansone Group for SW Hegener Drive consist of two lanes, with landscaping, from SW Anthony F. Sansone Sr. Boulevard to the east terminus of SW Hegener Drive, together with the installation of sidewalk and drainage improvements that will support the ultimate design for the roadway’s future buildout (the “Road Improvements”), and

WHEREAS, the Road Improvements have been completed in substantial conformance with the approved plans and the delivery of a Bill of Sale from the Sansone Group to the City of Port St. Lucie (“City”) shall serve to transfer the public roadway improvements located within the constructed portion of the SW Hegener Drive right-of-way; and

WHEREAS, pursuant to and in accordance with Section 156.150 of the City Code of Ordinances, Sansone Group has formally requested that the City accept the Road Improvements; and

WHEREAS, the City Engineer has caused the Road Improvements to be inspected and recommends that the City accept the Road Improvements so as to place said Road Improvements in the City’s ownership for responsibility and maintenance thereof; and

WHEREAS, the purpose of this Resolution is to formally accept ownership and maintenance responsibility of the completed Road Improvements.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY OF PORT ST. LUCIE, FLORIDA AS FOLLOWS, THAT:

RESOLUTION 25-R__

Section 1. Ratification of Recitals. The foregoing recitals are hereby ratified and confirmed as true and correct and are hereby made a part of this Resolution.

Section 2. Authorization. The City Council of the City of Port St. Lucie hereby authorizes the final acceptance of the completed construction of the SW Hegener Drive public roadway improvements dedicated to the City so as to place said improvements under the ownership and maintenance obligation of the City subject to the following condition:

Acceptance is not effective until the Developer provides the City with a maintenance bond approved by the City Attorney's Office and amends the Agreement for FPL Lighting to provide that the Developer is financially responsible for any restoration of the roadway necessitated by initial installation of FPL Lighting. Through this Resolution the City Council provides authority to the City Manager to sign such amendment to the Agreement for FPL Lighting.

Section 3. Conflict. If any resolutions or parts of any resolution, are in conflict herewith, this Resolution shall control to the extent of the conflicting provisions.

Section 4. Severability. The provisions of this Resolution are intended to be severable. If any part of this Resolution is determined to be void or is declared illegal, invalid, or unconstitutional by a Court of competent jurisdiction, the remainder of this Resolution shall remain in full force and effect.

Section 5. Effective Date. This Resolution shall become effective immediately upon adoption.
