

ORDINANCE 25-__

AN ORDINANCE OF THE CITY OF PORT ST. LUCIE, FLORIDA, ABANDONING A TEN (10) FOOT WIDE SIDE UTILITY AND DRAINAGE EASEMENT AFFECTING LOT 3, BLOCK 15, FIRST REPLAT IN PORT ST. LUCIE INDUSTRIAL PARK UNIT ONE, ACCORDING TO THE PLAT THEREOF, AS RECORDED IN PLAT BOOK 23, PAGES 6, 6A THROUGH 6D, OF THE PUBLIC RECORDS OF ST. LUCIE COUNTY, FLORIDA; PROVIDING FOR CONFLICT; PROVIDING FOR SEVERABILITY; AND PROVIDING AN EFFECTIVE DATE.

WHEREAS, the applicant, Sandra L. Bryla, as Trustee of the Land Trust No. Two dated April 6, 1990, as amended, requests approval for the abandonment of a ten (10) foot wide Utility and Drainage Easement located along the north side of the real property described as Lot 3, Block 15, First Replat in Port St. Lucie Industrial Park Unit One, according to the plat thereof, as recorded in Plat Book 23, Pages 6, 6A through 6D, of the Public Records of St. Lucie County, Florida, and more particularly described in Exhibit "A" which is attached hereto and incorporated herein.

NOW, THEREFORE, THE CITY OF PORT ST. LUCIE HEREBY ORDAINS:

Section 1. Ratification of Recitals. The foregoing recital is hereby ratified and confirmed as true and correct and is hereby made a part of this Ordinance.

Section 2. That the ten (10) foot wide Utility and Drainage Easement described in Exhibit "A" is hereby abandoned and any right, title or interest of the public in and to that Utility and Drainage Easement on any recorded map or plat is hereby renounced and reclaimed.

Section 3. The effect of this Ordinance is to abandon the ten (10) foot wide above-described Utility and Drainage Easement and to renounce or disclaim any right, title or interest of the public in and to said utility and drainage easement.

Section 4. Recordation. The City Council hereby directs that this Ordinance be recorded in the public records of St. Lucie County, Florida.

Section 5. Conflict. If any ordinances, or parts of ordinances, are in conflict herewith this Ordinance shall control to the extent of the conflicting provisions.

Section 6. Severability. The provisions of this Ordinance are intended to be severable. If any provision of this Ordinance is determined to be void or is declared illegal, invalid, or unconstitutional by a Court of competent jurisdiction, the remainder of this Ordinance shall remain in full force and effect.

Section 7. Effective Date. This Ordinance shall become effective ten (10) days after final adoption on second reading.
