**SUBJECT:** 2021 Legislative Session – Week 9 Summary (April 26 - 30)

The traditional hankie drop signaling the 2021 Legislative Session has adjourned <u>sine die</u> occurred at 2:41 p.m. on Friday. This session, and the final week specifically, was anything but normal. The Legislature and those in the process dealt with new COVID procedures; the Governor approved a gaming compact for the first time since 2015 (not ultimately approved); the Senate Democrats ousted their leader Sen. Gary Farmer in the last week replacing him with <u>Sen. Lauren Book</u>; and the House and Senate passed a <u>\$101.5 billion budget</u>, by a significant margin the largest in state history.

One normalcy in the final week was bills rapidly dying as the clock ticked down to sine die. Among the most noteworthy of the unresolved bills session was a rewrite of the state's data privacy laws. House Bill 969/Senate Bill 1734, which would have allowed consumers to opt out of companies selling their personal data and would have required companies to disclose the data they collected and what they intended to do with it, died in the final days. Florida's business community was against the legislation, as they said it could have the unintended consequences of leading to massive class action lawsuits and carried with it a significant regulatory and implementation cost.

Now, all eyes turn to Governor Ron DeSantis to see what legislation he signs into law, and what he vetoes. Many of the bills heading to his desk priorities of his, and consistent with his agenda. From this point on (outside of the session), the Governor will have 15 days to act on bills once they are presented to him by the legislature. To date, he has <u>signed seven bills</u> into law, which includes the Right to Farm bill – a major priority of the Senate President - that he signed this past Thursday. On Friday, he was also presented with the Emergency Management bill, on which he has until May 15 to act.

House Speaker Chris Sprowls and Senate President Wilton Simpson have also called a <u>Special</u> Session for the week of May 17 to address the <u>2021 Gaming Compact</u>. After months of

negotiations, <u>Governor DeSantis</u> and the Seminole Tribe of Florida executed a historic 30-year gaming compact that will need to be ratified by the Legislature. The Special Session will give lawmakers more time to vet what is in the compact.

On the COVID front, the Governor extended the declared State of Emergency yet again by signing Executive Order 21-94 on Tuesday. The extension is for another 60 days. The order stated, "The impact of COVID-19 poses a continuing threat to the health, safety, and welfare of the State of Florida and its residents." However, the Governor hinted that this may be the last extension as his executive order noted the state should "prepare to resume non-emergency operations."

All of these, our Federal Spotlight and current Session Statistics are detailed below.

# Activities on Behalf of Port St. Lucie

<u>Appropriations Projects</u> – Budget conference concluded on Monday with the budget hitting the desks of legislators on Tuesday at 12:06pm. That signaled the official countdown to *sine die*. The C-23 Water Quality Project (Phase 4) received full funding at \$1,024,862.

**Port St. Lucie Septic to Sewer Conversion Program** – HB 2123 and Senate #1952 – House Referred to Agriculture & Natural Resources Appropriations Committee. Approved on March 11. This project did not receive funding.

**Port St. Lucie – St. Lucie River/C-23 Water Quality Restoration Project (Areas 5 & 6) –** Senate #1958 and HB 2125 – Referred to Agriculture & Natural Resources Appropriations Subcommittee – Approved on March 3. This project did not receive funding.

**Port St. Lucie – St. Lucie River/C-23 Water Quality Restoration Project (Area 4)** – Senate #1957 and HB 2127 – Referred to Agriculture & Natural Resources Appropriations Subcommittee. This funded at \$1,024,862 (Line 1607A). Congrats!

**Hegener Drive Extension Tradition Center for Commerce** – HB 2159 and Senate #2038 – Referred to House Infrastructure & Tourism Appropriations Subcommittee. This project did not ultimately get funded.

Revising and deleting distributions of the documentary stamp tax; providing that specified distributions may not be transferred to the General Revenue Fund; revising the purposes for which distributions may be made from the Water Protection and Sustainability Program Trust Fund.

## Emergency Management – HB 7047 (Leek) and SB 2006 (Burgess)

#### Key Take Away

Revises & creates emergency management provisions relating to transfer & expenditure of moneys in Emergency Preparedness & Response Fund; state comprehensive emergency management plan; statewide awareness & education programs; personal protection equipment; contracts with providers for care of persons with disabilities or limitations; duration of emergency orders & rules issued by Governor; agency disaster preparedness plans; agency & political subdivision spending plans; significant emergency orders; emergency mitigation studies; DOH public health emergency plan; collection & reporting & publication of information by State Health Officer; & functions of district medical examiners.

## Tourist and Convention Development Taxes – HB 1429 (Avila) and SB 2008 (Diaz)

## Key Take Away

Proposing changes to the Tourist Development Tax (TDT) statute that would require a county to renew its existing TDT via referendum no later than July 1, 2026. If the TDT passed at that time, it would then have to be renewed every five (5) years thereafter via referendum. Any new pennies levied would also have to be approved via referendum.

If passed, would provide that regulations relating to building design elements may not be applied to residential dwellings unless they are historic properties; provides affected party may submit certain local government regulations to Florida Building Commission for review; provides for enforcement of such regulation.

# Combating Public Disorder – HB 1 (Fernandez-Barquin) and SB 484 (Burgess) - Approved by Governor; Chapter No. 2021-006

## Key Take Away

If passed, would increase several penalties for crimes committed in the course of a riot. Important to municipalities and counties, the legislation would provide an appeal mechanism for citizens to challenge a decrease in funding to the police department, as well waive sovereign immunity for municipalities that inhibit a local law enforcement's ability to protect citizens during a riot.

If passed, would revise definitions for "retail sale" and "mail order sale" to capture internet sales, and thus enforce the sales tax on internet sales. Amended to require certain amounts to be deposited into the Unemployment Compensation Trust Fund during specified periods and to offset the Business Rent Tax through a reduction from 5.5 to 2.0%.

Requires local governments to include property rights element in their comprehensive plans; provides statement of rights that local government may use; requires local government to adopt property rights element by specified date; prohibits local government's property rights element from conflicting with statutorily provided statement of rights; provides that certain property owners are not required to consent to development agreement changes; prohibits municipality from annexing specified areas; requires DOT to afford right of first refusal to certain individuals; provides requirements & procedures for right of first refusal; authorizes certain developments of regional impact agreements to be amended.

If passed, would preempt licensing of occupations to state; provide exceptions; prohibit local governments from imposing or modifying certain licensing requirements; specify that certain local licensing may not be enforced; specify that certain specialty contractors are not required to register with Construction Industry Licensing Board; prohibit local governments from requiring certain specialty contractors to obtain license; specify job scopes for which local government may not require license; authorize counties & municipalities to issue certain journeyman licenses.

## Reclaimed Water – SB 64 (Albritton) and HB 263 (Maggard)

#### Key Take Away

If passed, would require certain domestic wastewater utilities to submit to the Department of Environmental Protection by a specified date a plan for eliminating nonbeneficial surface water discharge within a specified timeframe; require domestic wastewater utilities applying for permits for new or expanded surface water discharges to prepare a specified plan for eliminating nonbeneficial discharges as part of its permit application; provide that

potable reuse is an alternative water supply and that projects relating to such reuse are eligible for alternative water supply funding; requiring counties, municipalities, and special districts to authorize graywater technologies under certain circumstances and to provide incentives for the implementation of such technologies, etc.

retroactively for a previous or current fiscal or calendar year. The impact fee limitations must operate retrospectively to January 1, 2021.

# Summary of Session Week 9 (April 26-30)

Emergency Management Legislation (HB 7047 by House Pandemics and Public Emergencies Committee and Rep. Leek/SB 2006 by Sen. Burgess) — The legislation would update the State Emergency Management Act to better address and minimize threats that arise due to pandemics or other public health emergencies. It would address planning and preparations; require greater transparency for emergency orders, delegated emergency powers, and emergency spending; and pull back the authority of local government emergency orders that restrict individual liberties, among other things. This priority legislation ultimately passed both chambers after ping-ponging between chambers. On Tuesday, the House took up the Senate version, amended it, and then on Wednesday passed it by a vote of 76-40, sending it back to the Senate. On Thursday, the Senate accepted the House's amendment, further amended the bill, and sent the bill back to the House by a vote of 23-15. That same day, the House approved of the bill by a vote of 78-36. On Friday, the bill was sent to the Governor, where he must act on it by May 15, 2021.

Impact Fees Legislation (HB 337 by Rep. DiCeglie/SB 750 by Sen. Gruters) — The bills include several provisions to restrict impact fees imposed by local governments or special districts, including a requirement that credits against the collection of impact fees any contribution related to public facilities. The legislation also specifies conditions under which local government, school districts, or special districts may increase impact fees. The House version passed last week with the support of Republicans and several Democrats, which is notable given the proposal's staunch opposition from local governments. The Senate took up the House bill on Monday and passed it by a vote of 28-12. The bill is now ready to be sent to the Governor.

Preemption Over Restriction of Utility Services Legislation (<u>HB 919 by Rep. Tomkow/SB 1128 by Sen. Hutson</u>) — The bills would block local ordinances restricting the types of fuel a utility may use, such as a ban on natural gas. The full House passed the bill with an 81-34 vote last week, sending the measure to the Senate. The Senate took up the House version and passed it on Monday by a 27-13 vote. The bill is now ready to be sent to the Governor.

Technology Transparency Legislation (HB 7013 by Rep. Ingoglia/SB 7072 by Senate Governmental Oversight and Accountability Committee) — The proposal, a Gov. DeSantis priority, would impose a series of requirements on social media companies aimed at ending the practice of "de-platforming" or "shadow banning" users. The bills would also require companies to spell out prohibited content that could lead to a ban and inform users of any changes to their terms of service. On Monday, the Senate passed its version of the bill by a vote of 22-17. On Tuesday, the House took up the Senate version, amended it, and voted it off the floor by a vote of 78-41 sending it back to the Senate. On Thursday, the Senate concurred with the House amendment, amended the bill even further, and passed the bill by a vote of 23-17, sending it back to the House. The House concurred with the Senate amendment and passed the Senate version of the bill by a vote of 77-38. The bill is now ready to be sent to the Governor.

Foreign Influence Legislation (HB 7017 by Rep. Grall/SB 2010 by Sen. Diaz) — The bills would require organizations seeking state funding to disclose any financial ties to adversarial countries or "foreign country of concern." The list includes China, Cuba, Iran, North Korea, Russia, Syria, and Venezuela. The legislation is a priority of Gov. DeSantis and House Speaker Chris Sprowls. On Monday, the Senate took up the House version and unanimously voted in favor of passing the bill. The bill is now ready to be sent to the Governor.

Election Administration Legislation (HB 7041 by Rep. Ingoglia/SB 90 by Sen. Baxley) — The legislation would change several election laws, most notably requiring oversight of mail ballot drop boxes, either by camera or elections supervisor staff. A provision that would have changed ballot signature verification rules was removed from the bill. On Monday, the Senate passed the bill by a vote of 23-17, sending it to the House where it was amended on Tuesday and passed by a vote of 77-40 on Wednesday. On Thursday, the Senate concurred with the House amendment, added their own amendment, sent it back to the House by a favorable vote of 23-17. The House passed it by a vote of 77-40. The bill is now ready to be sent to the Governor.

Volunteer Ambulance Services Legislation (<u>HB 805 by Rep. Caruso/SB 1084 by Sen. Pizzo</u>) — The bills aim to assist faith-based, not-for-profit volunteer ambulance services by prohibiting local governments from charging them licensing fees or banning their operation. Though few such providers exist in the state, lawmakers say populations with religious sensitivities rely on their services. On Monday, the Senate took up the House version and unanimously passed it. The bill is now ready to be sent to the Governor.

COVID-19 Impacts on Educational Institutions (HB 1261 by Rep. Toledo/SB 7070 by Senate Education Committee) — The bills would shield colleges and universities from lawsuits over decisions to close campuses because of the COVID-19 pandemic. The Senate bill would have provided the same protections to higher education institutions but would also have shielded K-12 schools from accountability measures based on standardized test scores this year. On Monday,

the Senate took up the House version and amended the bill. On Tuesday, the Senate unanimously passed the bill, sending it back to the House where the amendments were accepted and the House passed the bill by a vote of 102-11. The bill is now ready to be sent to the Governor.

State Preemption of Seaport Regulations Legislation (HB 267 by Rep. Roach/SB 426 by Sen. Boyd) — The bills would preempt local government ordinances that "restrict or regulate commerce" at Florida seaports. Originally, the Senate bill would have impacted multiple ports; however, it was narrowed to the point that it would only apply to Key West — which was the primary goal from the start. The bill would undo referenda approved by Key West voters last year, limiting the size and type of ships, as well as the volume of tourists who disembark at the port. The Senate version cleared the chamber floor with a 25-14 vote. On Monday, the House took up the Senate version and temporarily postponed the bill on second reading. The bill was never rescheduled for a vote; therefore, it died when the gavel came down on sine die. However, as the saying goes, nothing is ever dead in the Florida Legislature. On Wednesday, the sent back to the House where they concurred with the amendment and approved the bill by a vote of 75-40. Senate amended a revised version of the language onto the annual transportation bill (SB 1194). This bill was

**Building Design Legislation** (HB 55 by Rep. Overdorf/SB 284 by Sen. Perry) — The bills would preempt local ordinances restricting home design elements, such as exterior colors, window placement, or the location of a garage. On Monday, the House passed its version of the bill by a vote of 89-24 and sent it to the Senate where it died in the Senate Rules Committee. Sticking with the theme of nothing ever really dies, this bill was amended onto to a building code bill (HB 401) by the Senate on Monday after some ping-pong between the Chambers ultimately passed the House on Wednesday (102-12) and Senate on Thursday (38-1).

Civic Education Curriculum Legislation (HB 5 by Rep. Zika/SB 1450 by Sen. Rodriguez) — The bills would require high school government classes to include a comparative discussion of political ideologies, including communism. The proposal, a priority of House Speaker Sprowls, cleared the Senate on Monday with a unanimous vote. The bill is now ready to be sent to the Governor.

School Choice Legislation (<u>HB 7045 by Rep. Fine</u>) — Billed by its backers as the largest school choice expansion in Florida history, the sweeping education bill would shutter the Gardiner Scholarship Program and McKay Scholarship Program and transition students currently receiving those scholarships into the Family Empowerment Scholarship Program. It also increases voucher amounts from 95% to 100% for students in the Florida Tax Credit Scholarship Program, Family Empowerment Scholarship, and Hope Scholarship Program. On Monday, the Senate passed the bill by a vote of 25-14. The bill is now ready to be sent to the Governor.

Home Book Delivery for Elementary Students (<u>HB 3 by Rep. Trabulsy/SB 1372 by Sen.</u>

<u>Burgess</u>) — The bills would create the "New Worlds Reading Initiative," providing free books to elementary school students reading below grade level. One of House Speaker Sprowls' priorities, the Senate took up the House version of the bill and unanimously passed it. The bill is now ready to be sent to the Governor.

# Federal Spotlight

Biden's American Families Plan targets education, child care, paid leave - Reports about the contents of President Joe Biden's American Families Plan (AFP) have been circulating for weeks, but the President provided details in his address to a joint session of Congress on Wednesday night. Among other provisions, the AFP would make a "generation-defining investment in rural America." It would provide free universal preschool for all three- and four-year-olds and two years of free community college. It calls for additional funding for teacher education and training and more funding to train and recruit special education teachers. It would make child care more affordable and more accessible, especially in rural communities. It would create a comprehensive national paid family leave program and expand summer food access and school meal programs. It would extend the child tax credit, permanently increase tax credits for child care, and make the Earned Income Tax Credit permanent.

**How to pay for it -** The question, of course, is how the federal government can pay for the initiatives the President is proposing. President Biden outlined his recommendations for tax reform in Wednesday's speech. They include:

- Increasing the top marginal income tax rate to 39.6% for the top 1% of earners
- Increasing the capital gains tax rate to 39.6% for those earning more than \$1 million
- Applying the 3.8% Medicare tax "consistently" for those making more than \$400,000 a year
- Repealing the "step-up in basis" rule above the first \$1 million passed to an heir
- Ending "like-kind" or 1031 exchanges that allow real estate investors to defer tax payments by rolling proceeds of real estate sales into future purchases
- Treating compensation from carried interest like wage income instead of like capital gains for tax purposes
- Permanently extending current limits on excess business losses

Biden promised not to raise taxes on anyone earning less than \$400,000, but to improve IRS collection of past due taxes and enforcement against tax cheats.

Senator Warren has a plan - At a hearing of the Senate Finance Subcommittee on Fiscal Responsibility and Economic Growth on Tuesday, Subcommittee Chair Elizabeth Warren (D-MA) promoted three tax reform proposals of her own: a wealth tax of two cents on fortunes over \$50

million, a Real Corporate Profits Tax of 7% on companies that report profits of more than \$100 million to the shareholders and the public; and increasing tax enforcement against wealthy individuals and giant corporations. Senator Bill Cassidy (R-LA), the subcommittee's ranking member, said that Democratic tax proposals would pit Americans against each other and vilify success in business.

Treasury calls for broader IRS data collection, enforcement powers - Treasury Secretary Janet Yellen endorsed President Biden's proposed changes to the tax code, saying it would make the system more fair and help capture uncollected revenue. Treasury also endorsed proposed reforms to the IRS that it said would generate an additional \$700 billion in revenue without any increase in taxation rates. These reforms would provide the IRS with a sustained, multi-year stream of funding that would deliver about \$80 billion over a ten-year period. They would grant the IRS access to information financial institutions collect about the aggregate outflows and inflows of their customers' accounts. They would provide funding for the IRS to update its technology infrastructure, improve taxpayer service, and deliver tax credits. They would also give the IRS additional authority to regulate tax preparers.

Water/wastewater infras tructure bill gets overwhelming **Senate** support Yesterday the Senate voted <u>89-2</u> to approve S. 914, the <u>Drinking Water and Wastewater</u> Infrastructure Act of 2021. The legislation would reauthorize grants to state Clean Water and Drinking Water revolving funds and to programs funded under the Water Infrastructure Finance and Innovation Act. It would authorize the Environmental Protection Agency to make grants for improvements to drinking water and wastewater systems, including projects to replace lead drinking water pipes. It would also make more funding available for water infrastructure projects in rural and economically disadvantaged areas. The \$35 billion the legislation would provide is considerably below the \$56 billion included in President Biden's American Jobs Plan. On the House side, Energy and Commerce Committee Chairman Peter DeFazio (D-OR) has introduced his own bill, HR 1915, which would provide \$40 billion to the Clean Water State Revolving Fund and \$10 billion for other projects.
